**ORDINANCE NO. 11-002**

**AN ORDINANCE TO AFFIRM AN ENFORCING AGENCY TO DISCHARGE  
THE RESPONSIBILITY OF THE CHARTER TOWNSHIP OF JAMESTOWN  
LOCATED IN OTTAWA COUNTY, AND TO DESIGNATE REGULATED FLOOD  
HAZARD AREAS UNDER THE PROVISIONS OF THE STATE CONSTRUCTION  
CODE ACT, ACT NO. 230 OF THE PUBLIC ACTS OF 1972, AS AMENDED**

THE CHARTER TOWNSHIP OF JAMESTOWN ORDAINS:

**Section 1. Agency Designated.** Pursuant to the provisions of the state construction code, in accordance with Section 8b(6) of Act 230, of the Public Acts of 1972, as amended, the Building Official of the Charter Township of Jamestown is hereby designated as the enforcing agency to discharge the responsibility of the Charter Township of Jamestown under Act 230, of the Public Acts of 1972, as amended, State of Michigan. The Charter Township of Jamestown assumes responsibility for the administration and enforcement of said Act throughout the corporate limits of the community adopting this ordinance.

**Section 2. Code Appendix Enforced.** Pursuant to the provisions of the state construction code, in accordance with Section 8b(6) of Act 230, of the Public Acts of 1972, as amended, Appendix G of the Michigan Building Code shall be enforced by the enforcing agency within the Charter Township of Jamestown.

**Section 3. Designation of Regulated Flood Prone Hazard Areas.** The Federal Emergency Management Agency (FEMA) Flood Insurance Study (FIS) Entitled "Ottawa County, Michigan (All Jurisdictions)" and dated December 16, 2011 and the Flood Insurance Rate Map(s) (FIRMS) panel number(s) of 26139C; 0332E, 0335E, 0351E, 0352E, 0355E and 0356E and dated December 16, 2011, which maps are attached to this Ordinance, are adopted by reference for the purposes of administration of the Michigan Construction Code, and declared to be a part of Section 1612.3 of the Michigan Building Code, and to provide the content of the "Flood Hazards" section of Table R301.2(1) of the Michigan Residential Code.

**Section 4. Repeals.** All ordinances inconsistent with the provisions of this ordinance are hereby repealed.



**NOTICE OF ADOPTION OF TOWNSHIP ORDINANCE  
AND SUMMARY OF THE REGULATORY EFFECT THEREOF**

PUBLIC NOTICE IS HEREBY GIVEN that on November 21, 2011, the Township Board of the Charter Township of Jamestown adopted Ordinance No. 11-002, relating to regulated flood hazard areas. The principal terms of the ordinance can be summarized as follows:

1. Enforcing Agency. The ordinance designates the Township Building Official as the enforcing agency for the purpose of enforcing the Michigan Building Code and, in particular, for the purpose of enforcing the provisions of Appendix G, relating to flood-resistant construction.

2. Designation of Regulated Flood Hazard Prone Areas. Pursuant to the ordinance, the Federal Emergency Management Agency (FEMA) Flood Insurance Study (FIS) Entitled "Ottawa County, Michigan (All Jurisdictions)" and dated 12/16/11 and the Flood Insurance Rate Map(s) (FIRMS) panel numbers of 26139C; 0332E, 0335E, 0351E, 0352E, 0355E and 0356E and dated December 16, 2011, are adopted by reference for the purposes of administration of the Michigan Construction Code, and declared to be a part of Section 1612.3 of the Michigan Building Code, and to provide the content of the "Flood Hazards" section of Table R301.2(1) of the Michigan Residential Code.

3. Effective Date. The ordinance will become effective December 7, 2011. A copy of the ordinance may be inspected or purchased at the Jamestown Charter Township Hall, 2380 Riley Street, Jamestown, Michigan, 49427, during Township office hours.
