# FIRST READING OF ORDINANCE 2017-03 AMENDING TAKE HOME VEHICLE POLICY

First reading was given to Ordinance 2017-03 which shall Officer who reside in an adjoining county to Mercer County wishing to utilize this option shall pay a monthly reimbursement fee. The Chief of Police shall establish a per mile rate, subject to approval of the Harrodsburg City Commission. This mileage rate and the cumulative round trip mileage total from their residence to the Mercer County line shall be used to calculate this monthly fee. This fee only applies to an officer's regular tour of duty. Calls out, court appearances and training are exempt unless they immediately precede or follow a regular tour of duty.

#### WRECKER SERVICE AGREEMENT
