TAX LEVY ORDINANCE

ROAD DISTRICT

ORDINANCE NO. 2018-06

An ordinance levying taxes for all road purposes for ELA Road District LAKE County, Illinois, for the tax year 2018, collectable in 2019.

BE IT ORDAINED by the Board of Trustees of ELA Township, LAKE County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of ELA TOWNSHIP Road District on NOVEMBER 8, 2018, does hereby determine and declare that the sum of ONE MILLION, THREE HUNDRED & FOUR THOUSAND, FOUR HUNDRED & SEVENTY-NINE Dollars (\$1,304,479.00) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

to be raised by taxation for road purposes for ELA TOWNSHIP Road District.

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held  
invalid or to be unconstitutional, such finding shall not effect the validity of the remaining portion of this  
ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.


