TAX LEVY ORDINANCE

ROAD DISTRICT

ORDINANCE NO. 2017-07

An ordinance levying taxes for all road purposes for ELA Road District LAKE County, Illinois, for the tax year 2017_, collectable in 2018_.

BE IT ORDAINED by the Board of Trustees of ELA Township, LAKE County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of ELA TOWNSHIP Road District on NOVEMBER 9. 2017, does hereby determine and declare that the sum of ONE MILLION, TWO HUNDRED & SEVENTY-TWO THOUSAND, SIX HUNDRED & SIXTY-TWO Dollars (\$1,272,662.00) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:



of this ordinance.


SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary

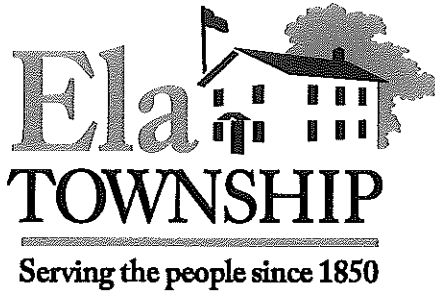
