

# Tuition Agreement

Morning Preschool hours are 8:30 a.m. - 11:30 AM. Lunch Bunch students may stay until 1:00 PM.

Extended Care is available only to students enrolled in Beth Israel Preschool’s morning program. Four Extended Care pickup times are available: Plan A- 3:00; Plan B – 4:00; Plan C- 5:00; Plan D- 6:00.

The calendar for Extended Care is August through May, which follows the Morning Preschool’s calendar. When the Morning Preschool is closed, Extended Care is closed. Please refer to our calendar if you have specific questions about the days school is closed. Extended Care students MAY arrive at 7:30 a.m., and remain until 6:00 p.m. Those arriving early must be in the building no later than 8:05 AM. Morning Only and Lunch Bunch students may pay an early drop off fee of \$25.00 per week.

The Mississippi State Department of Health regulations govern all Beth Israel Preschool and Extended Care policies. Beth Israel Preschool is licensed by the State of Mississippi. If regulations of the state change, it should be understood that Beth Israel Preschool will abide by such changes. Morning Preschool fees are the same for all students, regardless of age.

All children in the program attend five days a week. Tuition may be paid in TEN or TWELVE-monthly installments depending on your plan.

\*If tuition is paid in full before August 1, 2019, there will be a 2% discount.

Supply fees are due September 17, 2019

Fees are due the first day of each month. A late charge of \$40.00 will be levied to tuition RECEIVED BY US after the 2nd day of the month. Returned checks will be assessed a \$50.00 surcharge. If an ACH draft is returned, we will reprocess in three (3) business days unless you bring money order or certified check. Students will not be allowed to participate in school if fees are delinquent.

*There will be a late charge of \$10.00 per hour for late pick-ups before 6:00 p.m. There will be a late charge levied at the rate of \$6.00 a minute for pick-ups after 6:00 p.m. The second-time late charge is \$12.00 per minute past 6 o'clock. The third-time late charge is \$18.00 per minute past 6 o'clock. These charges are per child not per family and are due the next morning by 8:30 a.m. These charges are substantial but are nonnegotiable. We are licensed to operate no later than 6:00 PM.*

**Enrollment for Extended Care is for the entire ten-month school session. If a child must be withdrawn from Extended Care but remain in the morning program, you are required to give the school two (2) months' notice in writing. Our program requires a two (2) months' notice of withdrawal in writing. Failure to give proper notice of withdrawal from either program will result in your being required to pay for the time that your child was not in attendance (either two or four months, depending on the program).**

Tuition and fees are payable for each of the ten school months whether your child is present or absent, or whether the month is less than four weeks. Extended Care children arriving before 8:05 a.m. must be escorted into the building.

For a child to be eligible to participate in Extended Care, he/she must be pre-registered and paid-in-full for the school session beginning August 2019. If you desire a place for your child, please complete the form below and send it with your non-refundable fee for August Extended Care. The first fifty children to register will be guaranteed a place. If you are registering more than one child, you may pay for the second child by March 30, 2019.
