PARKING REGULATIONS 2018/2019

Parking on campus at VHS is restricted to students who have a parking permit. Permits must be displayed on the inside of the front window on the driver's side. Campus Security must affix all parking permits. Permits cost \$30.00 or \$25 with ASB card.

Due to limited parking, we have established guidelines for distribution of parking permits. Only Seniors are initially eligible for parking permits through the SECOND WEEK of school. After which VHS Administration may open up parking spots for all students based on availability.

To obtain a permit **you must provide this sheet initialed and signed by both parent and student with receipt of purchase**, a driver's license, car registration, valid insurance (per California State Law), and a VHS ID card. Parking permits will be applied to vehicles by security at 2:45pm after school, report to the front office to ask for assistance with this process. Only ONE permit will be issued per student. If a car is sold or a windshield replaced, the old permit **MUST BE REMOVED** and presented for a free replacement.

STUDENTS MAY NOT MOVE PARKING STICKERS TO ANOTHER CAR FOR ANY REASON. If a student moves their sticker to another car, they may lose parking privileges for the remainder of the school year.

If a student needs to drive a different car they must see the receptionist for a limited time temporary permit and display it on the dashboard or they WILL BE TICKETED.

ALL CARS PARKED IN THE STUDENT LOT MUST SHOW A PERMANENT OR TEMPORARY PARKING PERMIT REGISTERED TO THAT CAR AT ALL TIMES, OR THEY WILL BE TICKETED.

NOTE!! This is a REAL PARKING TICKET

(CA Vehicle Code Section 21113) - The bail will be indicated on the ticket, which will double if not paid within 21 days. The DMV can withhold renewal of your vehicle registration until the fees are paid. Payment is made to an outside agency not the school, see back of ticket for payment information.

I understand that violation of the following rules will result in a Parking Citation of \$35 or more; which will double and be sent to the DMV if not paid within 21 days. All tickets will be sent to an outside agency for payment to them directly and your DMV Registration may be delayed until the fees are paid.
