Limited Warranty Policy

1. Curb Dog Equipment Inc., (CDE) offers a limited warranty on each new machine against defects in material and workmanship under normal use and service for a period of one (1) year unless otherwise agreed to in writing by an authorized employee of CDE. This limited warranty commences on the day the customer receives delivery.
2. The obligation under this limited warranty is limited to the replacement or repair of parts and/or machines at a CDE factory branch or at an authorized CurbDog Equipment distributor. This decision is solely at the discretion of CurbDog Equipment.
3. Machines altered or modified without the express written consent by an authorized employee of CDE will nullify and void the expressed limited warranty. Misuse, negligence, accidents or the operation of machines in any way other than that recommended by CDE will void this limited warranty. This limited warranty shall not apply to machines repaired by service personnel other than those of CDE, their distributors or their factory branches.
4. This limited warranty includes labor on all CDE products. Labor must be performed at an authorized CDE distributor or by those companies or individuals designated by CDE. Should the repair or replacement of parts require an onsite visit by a factory representative the cost of transportation and other expenses connected therewith are not covered by this limited warranty and are the responsibility of the purchaser unless specifically agreed to in writing by an authorized employee of CurbDog Equipment.
5. Written authorization for the return of merchandise under limited warranty must be obtained from CDE, PO Box 2268, Estacada, OR 97023. This communication may be by fax, email or United States Postal Service delivery.
6. CDE reserves the right to inspect and render final decision on each limited warranty case.
7. CDE reserves the right to improve or make product changes without incurring any obligation to update, retrofit or install the same on machines previously sold. Wherever possible CurbDog Equipment will make available for purchase the improvements or changes if applicable. CurbDog Equipment reserves the right to improve or make product changes at any time without notification to past, present or future customers.
8. CDE is not responsible for any liability or damage or injury directly or indirectly incurred due to design, material or operation of its products. This limited warranty only applies to defects which have arisen solely from faulty materials or workmanship in the machines and does not apply to any other defects which may have arisen as a result of, Including, but not limited to:
 - Accidental damage, abuse, misuse, maltreatment, abnormal stress or strain of the machines;
 - Neglect of any kind in respect to the machine;
 - Damage or deterioration of finishes as a result of use, harsh conditions, lack of proper care or preventative maintenance;
 - Normal wear and tear;
 - Use or maintenance of the machines in any manner not approved or recommended by CurbDog Equipment including inadequate servicing, repair, and maintenance;
 - Alterations or repair of the machine other than approved in writing by an authorized employee of CDE;
 - Personal injury, property damage or economic loss, however caused, will not be covered by this limited warranty;

- 9. The following wearable parts and components are not covered by this limited warranty:
 - Engine: filter elements, belts, oil, fuel, grease, gaskets, O-rings and fittings;
 - Machine: lamps and lights, fuses, belts, chains, tires, valve stems, wire, hydraulic or fuel filter elements, batteries, grease, oil, gaskets, O-rings, hoses and fittings, sensors, transducers, sensor wands, gauges.
 - OEM Parts: Parts supplied by other manufacturers and used by CDE in the assembly of the machine which are covered by that manufacturer's warranty;
- 10. To be able to make a limited warranty claim the owner must;
 - a. Not modify, install or operate the machine in any manner, other than in accordance with the instruction manual, owner's manual or in any other manner not authorized in writing by an authorized employee of CDE;
 - b. Ensure that the machine has an operating hour meter throughout the period covered by this limited warranty.
 - c. Is responsible for all costs incurred as a result of a warranty claim including site access costs, site downtime and all transportation and shipping costs.
- 11. CDE will not cover the cost of parts, labor or travel incurred as a result of a malfunction of any non-genuine attachment or attachments fitted to the machine by the owner or others.
- 12. This limited warranty is not transferrable to another party beyond the original owner.
