Florin Gold Project

- Extensive gold-mineralized Tombstone intrusive rock complex within one of the world’s most prolific gold belts.
- 2.47 million ounces gold inferred mineral resource.*
- Encouraging geological, geochemical and geophysical evidence demonstrate that gold mineralization remains open in all directions laterally and to depth.
- Less than 1% of the project’s land package of 22,000 acres has been drill tested. Geochemical & geophysical data suggest that a very large volume of intrusive host rock remains to be tested laterally and at depth throughout the land package.
- Recommended budget to complete phase 1 and phase 2 work programs \$9.068 million (Ronald G. Simpson 2021)

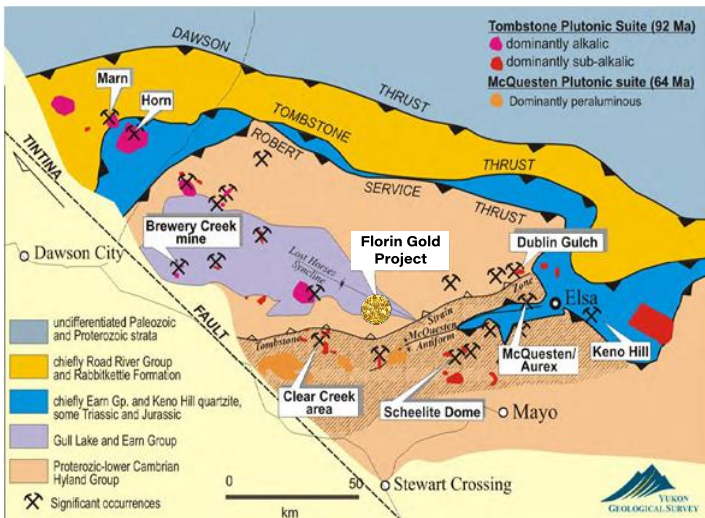


Resource Drilling Area

Key Technical Points

- Drilling in an around the inferred mineral resource area has not closed gold mineralization in any direction laterally or at depth, with the strongest mineralization open to extension along the NW Jethro Fault of the inferred mineral resource and along strike to the SE where the Jethro and Treadwell Faults intersect.
- A VTEM geophysical survey outlines the potential scope of the prospective volume of the intrusive host rock and identifies exploration targets for future drilling programs, both for potential expansion of the existing resource as well as additional target zones throughout the property.
- Successive geochemical exploration programs were successful in identifying the existing resource area. Additional geochemical exploration programs have recently identified additional prospective gold anomaly drill targets.

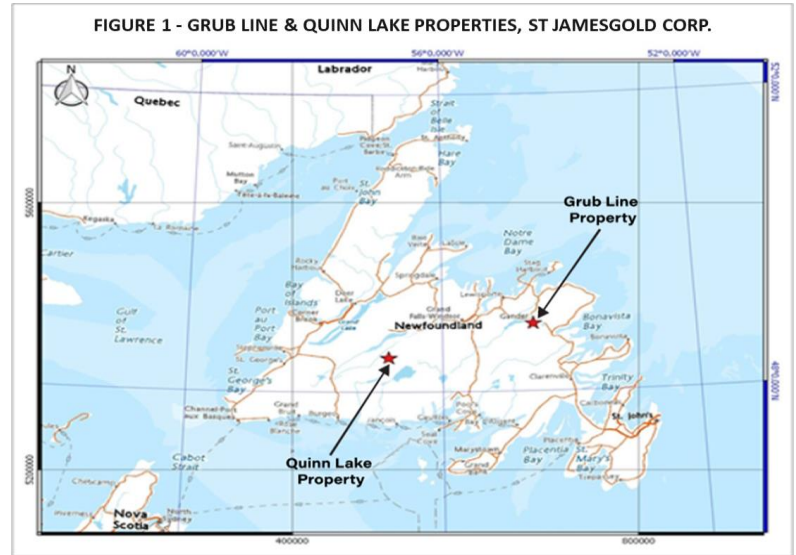
