

JURY & SELECTION PROCESS

With the Jury Application please include:

- **ONE** photograph each (3"x 5" or 4"x 6") of four different pieces completed within the past 24 months. (Please **DO NOT** send more than four photographs, or photographs larger than the sizes noted.)
- Label each photo on the back with the artist's name, dimensions of the artwork, medium and category to be juried.
- Jury fee of **\$30.00** (non-refundable), postmarked no later than **January 1st, 2021**. There will be a **2nd jury process** for applications postmarked after 1/1/2021. However, those applications require a **\$60.00** (non-refundable) fee per category which includes a late charge.
- **PLEASE NOTE:** Photos submitted for jury consideration will not be returned.

The nature of submissions must be themed **Art of the American West** and images submitted must be representative of the art that will be displayed if accepted into the show. Functional art will not be considered by the jury panel. Artists' works are not identified by name during the jury process. Jurying is conducted by a panel of experienced art professionals and is based solely upon the quality of work as illustrated in submitted photographs. Jury decisions are final.

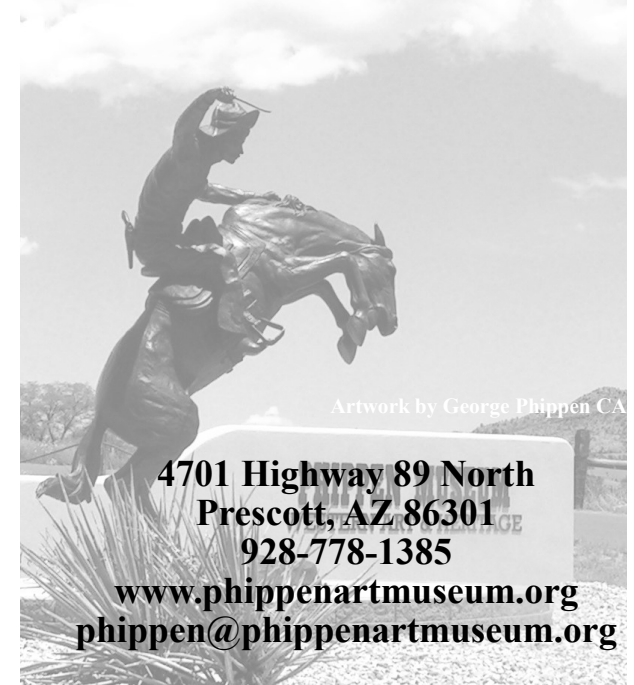

BOOTH INFORMATION

There are approximately 150 booth spaces and artists will be allocated a minimum of a 10'x15' space per booth. Electrical power is available for a limited number of booths (with an additional fee of \$15). Artists must provide their own display equipment, lighting, extension cords, etc. Canopies are recommended, but not required. Further information concerning site specifics will be provided with the artist acceptance packet. If juried into the show, all fees, including the booth fee of \$450, will be due by March 15th, 2021. Do not send fees until notified of acceptance. **Booth spaces are assigned on a first-paid basis.** All revenue from the sale of artwork will be retained by the artist. However, artists are responsible for any sales taxes.

PLEASE NOTE: If the Show should have to be cancelled due to the Covid-19 pandemic, we will hold a virtual event online to showcase the talent of our participating artists and any paid booth fees will be rolled over to 2022 or refunded.

This 47th annual celebration of western art is a highly-publicized outdoor art show held over Memorial Day weekend (May 29, 30 & 31, 2021) in beautiful downtown Prescott, Arizona. Please note there are rules and regulations pertaining to the use of the Courthouse Plaza that are **NOT** rules of the **PHIPPEN MUSEUM**. These rules must be complied with during the show and will be provided in the artist acceptance packet sent to you once your artwork has been juried and accepted.

The **PHIPPEN MUSEUM** will promote the Art Show extensively in national advertisements, newspaper articles, internet & radio.

ELIGIBILITY

The show is open to all artists submitting work featuring **Art of the American West** in the following seven media categories: **Acrylic, Drawing, Mixed Media, Oil, Pastel, Sculpture and Watercolor**. Awards will be given in each medium category. However, participation in any of the museum's previous shows does not guarantee acceptance.
