MEETING MINUTES

CURRENT STATUS: CANDIDATE FOR AUTO-APPROVAL ON JULY 26, 2016

CALL TO ORDER

Nick Sarwark called the meeting to order at 9:32 p.m. (all times Eastern)

ATTENDANCE

PURPOSE

The meeting was called for the purpose of discussing an encumbrance to place a candidate on the ballot for Washington D.C. delegate.

CANDIDATE FOR WASHINGTON, D.C. DELEGATE

Mr. Redpath moved to encumber \$8,000 for a petition drive for an office which would retain party ballot access in the District of Columbia if the candidate receives 7,500 votes.

Ms. Howell noted that there are two potential candidates interested in running for offices which could secure future ballot access, those being Martin Moulton for D.C. delegate and Matt Krokkel for at-large city council. Each candidate would need 3,000 signatures by August 10 to achieve ballot status. If either of those candidates receives 7,500 votes in November, the party's 2018 candidates could run very easily, and there would be 5 races in 2018 which would have a chance of securing ballot access for our presidential ticket in 2020. The ballot drive for our 2016 presidential ticket only has 1,000 signatures of the 7,000 target, and an extra petition drive could attract more petitioners.

Following debate, Mr. Redpath moved to amend the main motion so that it would become to encumber \$16,000 for two petition drives for offices which would retain party ballot access in the District of Columbia if the candidate receives 7,500 votes. There was no objection to the amendment.

Following additional debate, the vote on the main motion as amended was as follows:

Voting "aye": Goldstein, Hagan, Lark, Mattson, Redpath, Vohra

Voting "no": (none)

Abstaining: Sarwark

The motion was adopted with a vote total of 6-0.

NEW HAMPSHIRE BALLOT ACCESS

Mr. Redpath moved to increase the existing ballot access encumbrance for New Hampshire from \$15,000 to \$20,000.

Mr. Benedict explained that the additional funds will be used to send Nick Dunbar and Andy Burns to New Hampshire to help recruit additional petitioners and to gather signatures.

Following debate, the vote on the main motion was as follows:

Voting "aye": Goldstein, Hagan, Lark, Mattson, Redpath, Vohra

Voting "no": (none)

Abstaining: Sarwark

The motion was adopted with a vote total of 6-0.
