I, Timothy Perkins, declare as follows:

1. I am the Chair of the Libertarian Party of Oregon (“LPO”) Board of Directors. I was elected to that position in 2019 and have been a member of the LPO since 2016.
2. The 2020 LPO primary election ballots were mailed to over 19,000 Libertarian registered voters on June 8, 2020. The ballot return date was July 6, 2020.
3. I personally hand counted the ballots that the LPO received during the 2020 primary election. There were 609 timely, signed, and counted ballots.
4. Sandra Nelson and Harmony Mulkey received unopposed LPO nominations. Kim Thatcher ran, but lost to Kyle Markley. Tim Reeves did not run in the LPO primary.
