RULES AND REGULATIONS — DETROIT KENNEL CLUB, INC.

ARRANGEMENT OF EXHIBITS: Vendors must agree to arrange their booths so as not to obstruct the general view or hide exhibits of others.

INSTALLATION OF EXHIBITS: Arrangement of exhibits and removal of all boxes and crates must be completed by 8:00 am of the first day of the show weekend.

CARE OF THE BUILDING: Nothing will be taped or otherwise fastened to the walls of the building. Acceptance of exhibit space makes it obligatory on the part of the vendor that s/he shall not deface, injure or mar the Suburban Collection Showplace. Any damage done shall be made good by them to the Detroit Kennel Club (DKC) or the Suburban Collection Showplace. The vendor is liable for property belonging to the Suburban Collection Showplace.

INSURANCE: Vendors wishing to insure their goods must do so at their own expense. Neither the DKC nor the Suburban Collection Showplace assumes any responsibility for the safety of the property of the vendor, its officers, agents, or employees for theft, damage by fire, accident, or other causes.

RESTRICTIONS: The DKC reserves the right to restrict exhibits, which, because of noise, or for any other reasons, becomes objectionable, and also to prohibit an exhibit which in their judgment, may detract from the general character of the show. This reservation includes persons, things, conduct, printed matter or anything of a character that might be objectionable to the exhibit as a whole. By way of illustration only and not limitation, vendors shall not directly or indirectly circulate or cause to be circulated petitions for signature or engage in similar activities. All food and beverages to be consumed at the show site must be purchased from the approved concessionaire.

LIABILITY: Neither the DKC nor the Suburban Collection Showplace will be responsible for the fulfillment of this contract as the delivery of space if non-delivery is due to any one of the following causes: by reason of the building being destroyed by fire, act of God, public enemy, strikes, the authority of the law, or any cause beyond their control. Vendor agrees to indemnify and hold harmless the DKC and the Suburban Collection Showplace for all liabilities, claims, costs, and expenses relating to arising out of Vendor's acts or omissions.

MATERIALS: All material for display purposes must adhere to the regulations of the Suburban Collection Showplace and the Novi, Michigan fire department. Vendor's use of dogs or other livestock for demonstration purposes is prohibited.

REMOVAL: All materials must be removed by midnight on the last day of the show. Any vendors who fail to comply will be responsible for a financial penalty.

ELECTRICAL: Outlets must be contracted through Art Craft at The Suburban Collection Showplace (248)380-0843.

These rules and regulations are enforced by the Show Committee of the Detroit Kennel Club, Inc. They have been formulated for the best interests of the vendors as well as the Suburban Collection Showplace, and the vendors are respectfully asked to cooperate in the observance of them.
