MINOR RELEASE, WAIVER OF LIABILITY & INDEMNITY AGREEMENT

This Release, Waiver of Liability and Indemnity Agreement (the "Release") is made to release all liability for property damage, bodily injury of any type even death, that may arise while I or my children are on the property known as **Nocona Motorsports Park located** at 1153 FM 1759 Nocona, TX 76255

- 1) I individually and as the parent or legal guardian of the minor children named below acknowledge and agree to all of the terms set forth in this release. The words "I" "me" and "my" in this release shall refer to myself and my minor children listed below.
- 2) I indemnify and expressly waive all rights I may have to bring lawsuit, cause or claim of any kind against the property owner and their representatives, agents, employee or affiliates, for any damages/injuries I incur while on the property.
- 3) I assume full responsibility for any and all property damage, bodily injury even death I acknowledge the activities including but are not limited to riding and racing motorcycles, 4 wheelers, ATV (all-terrain vehicles) or UTV (utility task vehicles) involve a significant degree of risk to my property as well as injury or death to myself or my minor children.

- 7) I agree the Owner can remove me from the park at any time for any reason.
- 8) I agree that this release is in effect upon signing and shall remain in effect until such time as we receive in writing your request to withdraw your consent.
