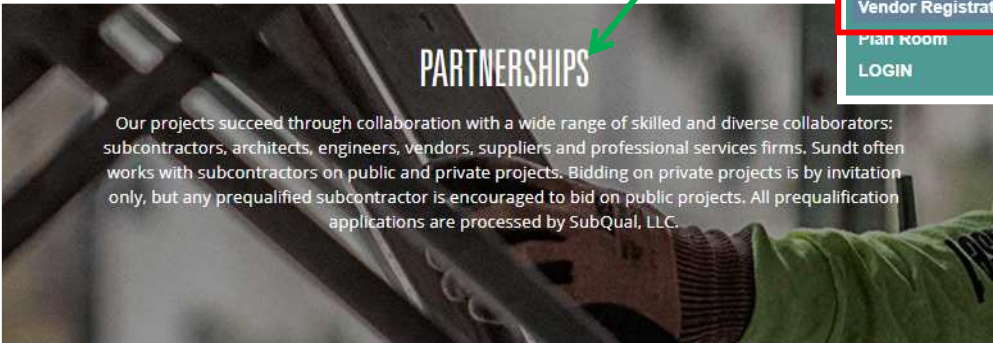
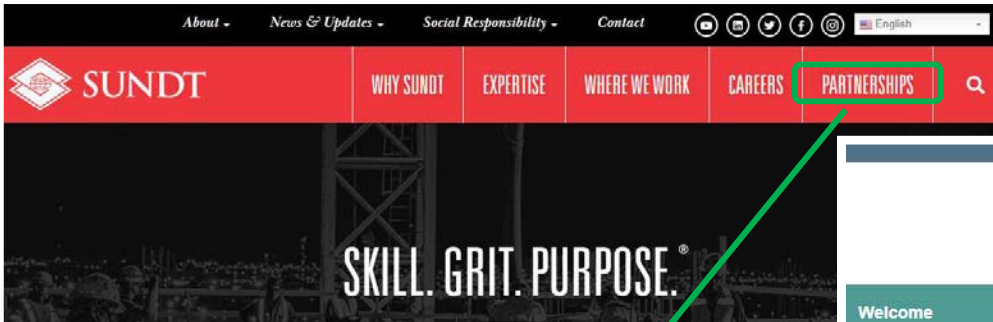

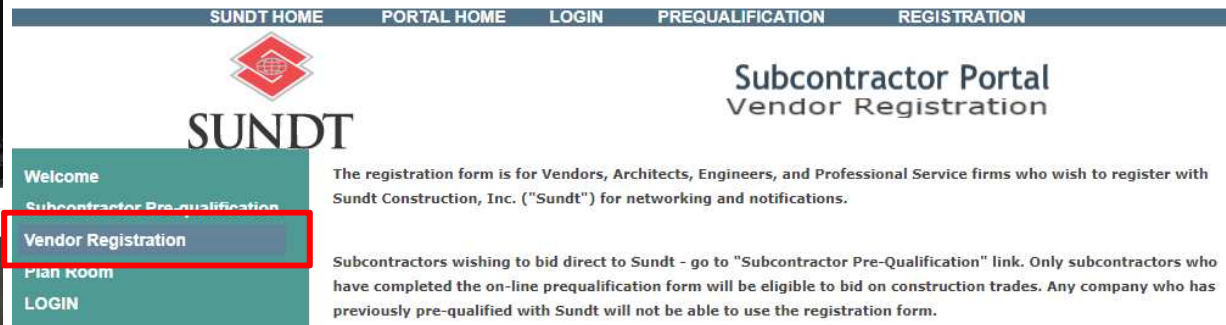

- Professional Service Agreements (POA)
- Barricades
- Concrete Pumpers
- Equipment Rentals
- Final Clean
- Furniture Installers
- Janitorial
- Pest Control
- Scaffolding Suppliers with no construction responsibility
- Sand Blasting
- Security Guard Companies
- Window/Power Washing
- Street Sweepers
- Temporary Fencing
- Temporary Power
- Traffic Control
- Truckers, Haulers
- Water Trucks (Dust Control)
