The **Glacial Lakes Brewers**, a local brew club, would like to invite your brewery to participate in the Fifth Annual:

We are hosting this exciting event outdoors in the parking lot of the historic **Butler Building** in downtown Aitkin, Minnesota (301 Minnesota Avenue North).

All we ask is that you bring your best beers and allow our patrons to meet your brewery representative(s) and sample your beers. Your participation will include two free general admission passes to the event, a complete promotional and marketing package (free publicity for your brewery), two chairs, ice, dump buckets, water stations, and garbage cans (just bring your own table). You will need to provide beer, jockey boxes, CO₂, tubs, signs, pop-up tent (bring weights as no stakes will be allowed), banners, rope, ice coolers and any merchandise you wish. 2017 marketing included Hubbard Broadcasting radio, City Pages, local newspapers and magazines and, of course, posters, flyers, social media that rounded out the exposure (we attracted 79 zip codes to the event!)

Last year's Harvest Moon Brew Fest attracted over 450 people and featured beers from several home brewers as well as **Big Axe Brewery, Castle Danger Brewery, Cuyuna Brewing Company, Jack Pine Brewery, Roundhouse Brewery, Sociable Cider Werks, Surly Brewing Company, and Sapsucker Farms Yellow Belly Cider**. Overall, we had more than 60 beers available to our festival attendees.

The **Harvest Moon Brew Fest 2018** will feature **Minnesota Craft Beers** (with a focus on Central and Northern Minnesota breweries), **Glacial Lakes Brewers** home brews, food trucks, games, live music and more. Details will be posted on our website and Facebook page as they become available:
