



# Cardisio Screening Result - C1000012.TXT

Dear Patient,

thank you for taking the Cardisio heart-screening test. It is a widely known fact that more than ten percent of the population has coronary heart disease, a condition where plaque accumulates in the heart's arteries. This condition is also known as arteriosclerosis or hardening of the arteries. Once detected, this condition can be treated. If untreated, however, leads to reduced blood flow to the heart and in many cases culminates in a potentially fatal heart attack.

Most people suffering from coronary heart disease are asymptomatic and will only learn about their condition when they experience a heart attack. This is because there hasn't been an effective, non-invasive and inexpensive method to screen for coronary heart disease. The Cardisio test solves this problem by taking three-dimensional measurements of the heart's blood flow and comparing an individual's data against a large heart database.

The Cardisio test has been optimized to diagnose true negatives, meaning when people receive an index below 0.5 in the green area of the scale, it is with virtual certainty that they are not at risk for a heart attack. At the same time, a test returning an index above 0.5 within the red area of the scale indicates an increased chance for coronary heart disease. This does NOT constitute an actual diagnosis, but instead simply serves as an indication that the person should consult a cardiologist for further testing.

Dear, C1000012.TXT, the screening-index on your Cardisio test indicates that you should undergo further screening for coronary heart disease. Please note: this does not mean that you have been diagnosed with coronary heart disease; it simply means we recommend further screening.

It is important to know that once diagnosed, there is a plethora of medical interventions that will avoid the potentially harmful consequences associated with coronary heart disease. The most important part is being diagnosed before you experience any symptoms or even a heart attack.

Take a look at the two diagrams below. Figure 1 graphically depicts the Cardisio measurement of a healthy heart, and you will see that your heart, as shown in Figure 2, appears to look different.







Your patient, C1000012.TXT, has taken an innovative test to screen for coronary heart disease developed by Cardisio GmbH in Germany. Based on this test, we have concluded that C1000012.TXT has an elevated risk for coronary heart disease.

The Cardisio heart screening test is a highly-accurate, non-invasive test to diagnose coronary heart disease with a sensitivity of 98% and a specificity of 85%. In its development, the Cardisio screening test was correlated with matching representative cohorts, including more than 600 patients with clinical indication for a coronary angiogram.
