						<p><b>Matches</b></p> <p>Ensure appropriate warm up activity takes place due to potential long periods of reduced activity and to avoid injury.</p> <p>If any person on site becomes symptomatic during or before the sessions, they should follow the FA guidance and should not attend the site or be immediately sent home if symptoms commence during the session. Full details available in the FA guidance.</p> <p>NHS and government guidelines should be followed in relation to further management of the symptoms.</p> <p>Players and coaches must avoid touching the football with their hands wherever possible. No other equipment should be touched by players.</p> <p>All equipment will be monitored and cleaned after the session by the coaches.</p> <p>All members should bring with them their own named water bottle and hand sanitiser as no refreshments will be available on site.</p> <p>Players should refrain from spitting.</p> <p>After the session has finished all parents and members should leave the venue immediately and not congregate.</p> <p>All members will be reminded to use hand sanitiser before entering the facility and when leaving.</p>	<p>Oliver Byron/Coaches</p>	<p>22 June 2020</p>

						<p><b>Changing Facilities</b></p> <p>We ask for players (where possible) to arrive at the facility changed into their match kit. Changing facilities are limited. Where changing facilities are a necessity then a changing area will be made available for up to 6 people at a time. After use, the changing area will be thoroughly cleaned and disinfected.</p> <p><b>Temperature Checks</b></p> <p>Visiting players will be temperature checked upon arrival at the facility, any visitor with a temperature above the recommended guidance will not be allowed access to the facility.</p> <p><b>Equipment</b></p> <p>All equipment will be washed using antibacterial dip/wash which will be available at entrance and exit of 3G pitch. All equipment including footballs to be cleaned using this before and after sessions. A cleaning record will be implemented to ensure this is done.</p> <p><b>Kit</b></p> <p>Kit must not be shared between players and should be taken home to be washed.</p> <p><b>Parents/Spectators</b></p> <p>Whilst we cannot allow spectators into the facility, friends and family are welcome to watch games. Please observe 2 metre social distancing rules wherever possible. Pitches are clearly marked with 2 metre social distancing lines to help. Lack of Awareness					<p>If a player requires First Aid, then this should primarily be done by a parent or guardian of the child.</p> <p>If further First Aid is required, PPE equipment must be worn by the First Aider before tending to the player. This equipment will be available via "Grab Packs" which will be located in each corner of the pitch.</p> <p>In the unlikely event of anyone requiring CPR then the First Aider must cover the persons mouth and nose with a piece of clothing or towel and use chest compressions ONLY.</p>	Pete Colclough	22 June 2020

**Additional comments:**

1. This risk assessment needs to be discussed with employees before they operate the plant/equipment to ensure compliance with all control measures through their understanding
2. Employees are to sign an acknowledgement sheet for their understanding of this risk assessment
3. The risk assessment is to be reviewed on an annual basis, or sooner if changes are made to the plant or working practices, or after an accident/near miss
4. This risk assessment must be approved by the nominated person for health and safety before being issued as a live document
