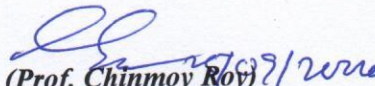

Note: Practical Examination for all subjects having practical paper will be held form 30.09.2020 to 13.10.2020 with Internal Examiners only. Accordingly college authority will notify the practical routine as per their convenience to complete the process within given timeframe.

- 1) All Principals of General Degree Colleges, Tripura and Director of Distance Education, Tripura University are requested to ensure that all forms, fees and relevant documents of the candidates are to be submitted to the University strictly adhering to the above programme and instructions are given below:
- 2) 70 % of the Centre fee deposited by the candidates may be retained by the College as per University norms. Statement showing details of fees and cost of application forms collected from the candidates along with deduction shall have to be submitted by the college at the time of submission of application forms to the university.
- 3) The College authorities are requested to submit the fees in demand draft or by cheque drawn on State Bank of India, Tripura University Campus Branch in favour of Tripura University on or before the dates fixed by the University OR through RTGC [Internal Receipt Fund A/C: 30863114537, State Bank of India (SBI), Tripura University Campus Branch, IFSC: SBIN0010495].
- 4) If any student has more than one subject to appear on the same day and at the same time the matter may be reported to the undersigned within 30.09.2020 positively.
- 5) Examinations fee for all Semester will be as per the University rate notified vide dated 24.09.2020.
- 6) Remarks: If any situation arises due to unavoidable circumstances the examination routine may be altered/ changed accordingly. However, any change in the above schedule will be circulated through University website (www.tripurauniv.ac.in) and will also be informed to the College authority through mail communication.
- 7) The College authority shall coordinate the Online Examinations strictly adhering to the Guidelines issued by the Registrar of Tripura University Vide No.F/TU/COE/UG-S/07/2019 dated 15.09.2020 with minor modification of Point No. 15 relating to submission of Answer Script which will be one hour instead of 24 hours as per UGC guidelines and decision of the state High Power Committee (Higher Education) meeting held on 24.09.2020.
- 8) The students must send the Answer Script to the college within ONE HOUR from the completion of examination of particular paper as per routine issued by Tripura University as per UGC instruction.
