Two Ways to Leave a Legacy Gift

There are two ways in which you can leave a legacy gift:

1. Incorporate the following wording into your Will:

I give ____% of my residuary estate (OR "I give the sum of £____ (*amount in words, pounds only*) free of all taxes to DAI UK (registered charity number 1115741, company number 50750186) for its general purposes and I declare that the receipt of an officer of the company shall be a sufficient discharge to my executors and trustees.

2. Add a Codicil to your Will; a proforma is provided on the next page.

Leaving a gift to DAI UK in your Will can have an impact on the calculation of Inheritance Tax. Your donation will either:

- be taken off the value of your estate before Inheritance Tax is calculated
- reduce your Inheritance Tax rate, if more than 10% of your estate is left to charity
