Adroddiadau'r Cynghorydd Sir.

Amlinellodd y Cyng Timms y gweithgareddau yr oedd y Cyngor Sir wedi'u gwneud mewn ymateb i bandemig COVID-19. Dywedodd wrth yr Aelodau fod y nifer cychwynnol o grantiau busnes yn Llangollen yn is na rhannau eraill o'r sir, sef tua 65% i'w gymharu â 75%. Bwriad y Cyngor Sir oedd cysylltu â phobl nad ydynt wedi derbyn grantiau i weld a oedd angen cymorth arnynt. Bydd Swyddogion y Cyngor Sir yn gwneud hyn yn ystod yr wythnosau nesaf. Yn yr un modd â sectorau eraill, ymdrechwyd i sicrhau bod Offer Amddiffynnol Personol ar gael ar gyfer Staff Gwasanaethau Cymdeithasol a Gofal. Yn ddiweddar, mae nifer o swyddogion wedi cael eu secondio i weithio ar y timau tracio, olrhain ac ynysu sydd wedi'u sefydlu gan Fwrdd Iechyd Prifysgol Betsi Cadwallader. Dywedodd y Cyng Timms hefyd na fyddai'r gwasanaethau amwynder dinesig yn dychwelyd i Langollen. Roedd hyn yn destun pryder iddo ef ac i'r Cynghorydd Mile, o ystyried agosrwydd safleoedd eraill yn Sir Ddinbych. Fodd bynnag, roedd y Cyngor Sir hefyd yn ymwybodol o rai o'r problemau a gafwyd yn Wrecsam lle bu'n rhaid i'r heddlu ymyrryd i gau safleoedd amwynder. O'r herwydd, roedd y sefyllfa'n cael ei hadolygu.

Gan nad oedd unrhyw eitemau pellach, daeth y cyfarfod i ben am 6.55 y.h.

County Councillor's Reports.

Cllr Timms outlined the activities the County Council had been undertaking in response to the COVID-19 pandemic. He advised Members that the initial take up of business grants in Llangollen was lower than other parts of the county at about 65% opposed to 75%. It was the County Council's intention to contact people that have not taken up grants to see if they required support. This would be undertaken by officers of the County Council over the next few weeks. As with other sectors, a lot of activity had been undertaken in order to secure PPE for Social Services and Care Staff and more recently a number of officers were being seconded to work on the trace, track and isolate teams that have been set up by the Betsi Cadwallader University Health Board. Cllr Timms also mentioned the fact that the civic amenity services will not be returning to Llangollen and this was of concern to both himself and Cllr Mile, given the proximity of other sites within Denbighshire. However, the County Council were also aware of some of the problems which have been encountered in Wrexham which had required intervention from the police to close down amenity sites and therefore the situation was under review.
