**Reports to Town Council.**

Denbighshire County Council.  
County Councillor Graham Timms addressed the meeting. Further to the earlier discussions on the local sustainable transport response to Covid-19 and the specific proposals for Llangollen, Cllr Timms confirmed that he had requested if half an hour free parking could be provided at all town centre car parks in Llangollen to compensate for the loss of on street car parking. Whilst this was being considered at a high level in the County Council, there were some concerns that this would have to be applied uniformly across the County and clearly in some towns a different approach may be required. Cllr Timms advised that the

Roedd wedi cychwyn gweithredu ar 1 Ebrill 2020 ac o ganlyniad nid oedd ganddo incwm o gwbl oherwydd i'r holl gyfleusterau gael eu cau. Dywedodd y Cyngorydd Timms fod pob un o'r ysgolion lleol wedi ail-agor yn ystod y tair wythnos diwethaf. Yn anffodus, dim ond 50% o bresenoldeb a gafwyd. O ran llywodraethu corfforaethol, roedd y Cyngor Sir wedi canslo pwyllgorau a byddent yn defnyddio system fideo-gynadledda amgen ar gyfer cyfarfodydd. Derbyniwyd yn gyffredinol bod cyfyngiadau i'r dull hwn o gyfathrebu. Roedd y Cyngor Sir hefyd yn edrych ar weithrediad yr un ar bymtheg o feysydd gweithgaredd yn y Cyngor Sir i ddadansoddi'r gofynion ar ôl Cofid. Yn olaf, atgoffodd y Cyngorydd Timms yr Aelodau o'r cronfeydd fferm wynt a fyddai ar gael yn fuan ac y dylid manteisio arnynt.

County Council's budget was under strain due to the impact of supporting Covid -19 recovery actions. Funds would ultimately be forthcoming from the Welsh Government in due course. However, one significant concern was the newly established arm's-length company Denbighshire Leisure Ltd formed to manage council facilities such as SC2, Rhyl's Pavilion Theatre, Prestatyn Nova Centre and all leisure centres which had started operations on the 1st of April 2020 and as a consequence had no income whatsoever due to the closure of all the facilities. Cllr Timms advised Members that all local schools had opened over the last three weeks. Unfortunately, only 50% attendance had been achieved. In respect to corporate governance the County Council had cancelled committees and would be moving to an alternative video conferencing system for meetings. It was generally accepted that this method of communication had its limitations. The County Council were also looking at the operation of the seventeen areas of activity within the County Council to analyse the requirements post Covid. In closing Cllr Timms reminded Members of the windfarm funds that would be available soon and should be taken advantage of.
