Gofynnodd Mr C Smith i'r Aelodau beth mae Cyngor y Dref am wneud ynglŷn â'r ymddygiad gwrthgymdeithasol rheolaidd sy'n digwydd yn Llangollen pan fydd y 'Teithwyr' yn dod i'r dref. Mynegodd Mr Smith bryder ynghylch eu hymddygiad a oedd yn gwaethgu ac roedd o'r farn y dylid sortio'r broblem ar frys. Y prif fater arall oedd faniau hufen iâ symudol sydd bellach yn ymweld â Llangollen ac yn parcio ar y stryd am y prynhawn cyfan. Nid oes ganddynt hawl i wneud hyn gan nad oes ganddynt drwydded i fasnachu ar y stryd, ond ymddengys na all neb wneud dim yn ei gylch.

Statements from the public.

Mr C. Smith addressed the meeting to ask what the Town Council is proposing to do about the regular anti-social behaviour which is occurring in Llangollen when the 'travellers' descend on our town. Mr Smith expressed concern over their behaviour which was getting worse and needs sorting urgently. The other major issue was mobile ice-cream vans that now visit Llangollen and just park up on the street for the whole afternoon. This is not allowed as they do not have a licence to trade on the street, but no-one seems able to do anything about it.

Anerchodd Mr Carrol y cyfarfod i ofyn am wybodaeth ynghylch pryd y byddai'r broses o ehangu'r palmant yn y dref yn digwydd, fel rhan o'r camau adfer ar ôl Cofid-19. Dywedwyd wrth Mr Carroll fod hwn yn fater i'r Sir ac fe wnaeth y Cynghorydd Sir, sef y Cynhorydd Mile roi goleuni iddo ar y llinell amser a'r prosiect.

Mr Carrol addressed the meeting seeking information on when the process of widening the pavement in town would be transpiring as part of the post Covid-19 recovery actions. Mr Carrol was advised this was a County matter and County Councillor Mile was able to advise him of the timeline or the project.

C/188/20(c) Soniodd Mrs H. Bailey wrth yr Aelodau am y datblygiadau preswyl oddi ar Ffordd y Ficerdy. Roedd hi'n pryderu y byddai'r bwriad o godi tri annedd teras deulawr ar safle Cartref Nyrsio'r Hen Ficerdy yn ychwanegu at y problemau traffig presennol ar Ffordd y Ficerdy. Roedd Mrs Bailey yn dymuno tynnu sylw Cyngor y Dref at y problemau a gafodd trigolion Ffordd y Ficerdy oherwydd y datblygiadau a fu yn y cyffiniau yn ystod y flwyddyn ddiwethaf. Mae Hafren Dyfrdwy wedi gadael y safle erbyn hyn, sydd wedi gwella'r sefyllfa rywfaint. Fodd bynnag, mae yna broblemau o hyd gan nad yw'r datblygwyr eraill yn defnyddio'r fynedfa gywir i'r safle. Mae eu cerbydau cludo'n dal i ddefnyddio Ffordd y Ficerdy yn hytrach na Ffordd y Bryn i fynd a dod i'r safle. Ychwanegodd Mrs Bailey ei bod yn poeni parthed materion amgylcheddol, a'i bod eisoes wedi cyfeirio'i phryderon at Gyfoeth Naturiol Cymru.

Mrs H. Bailey addressed the meeting regarding residential developments accessed off Vicarage Road. She had concern over the proposed erection of three two storey terraced dwellings at the site of the Old Vicarage Nursing Home which would add to the existing traffic problems on Vicarage Road. Mrs Bailey wished to draw to the attention of the town council the problems that have been experienced by residents on Vicarage Road regarding the developments that (it) occurred in the vicinity over the year. Hafren Dyfrdwy had now left the site which is making the situation somewhat easier however there were still problems with other developers not using the designated approach to the site and still using Vicarage Road and not Hill Street as site access for delivery vehicles. Mrs Bailey also commented another concern she had regarding environmental matters which she had referred to Natural Resources Wales.
