Capital Projects.
Members received a report on financial support for the following capital projects. Tri-Town share and repair shed.
The Town Clerk advised members that following a risk assessment undertaken in line with the Town Council financial regulations that there were significant risks associated with these projects as he highlighted to Members at a recent budget workshop. Despite the reservations of the Town Clerk a majority of Members wished to continue to progress this project and suggested the Town Council signs the offer letter on the proviso that the Town Council would not commit to any expenses on the project until a final decision was taken by the Town Council in February once a decision was received from the National Lottery on an application for revenue funding. The Town Clerk reminded Councillors that he had a legal duty to advise that if the Town Council were minded to take this course of action it would be contrary to the statement in the application form that if matched funding is not secured by October 2020, Llangollen Town Council would not be in a position to proceed with this project and the subsequent resolution of the Town Council. The key issues identified in the risk assessment were the power to undertake highways works and the limitations imposed on the Town Council if it agreed

There were some concerns over the fact that a number of businesses were using the extra space for A boards, even though the properties were some distance from where they have been placed. Clearly this was causing a problem and was against the principal of creating adequate social distance for pedestrians.
