Town hall emergency repairs: Suspension of standing orders and financial regulations.

Members considered a report and a risk assessment regarding the suspension of standing orders and financial regulations to facilitate emergency repairs to the town hall roof.

It was proposed, seconded, and resolved that the Town Council: -

It was proposed, seconded, and resolved that the Town Council allocates £1,500 from the community cost centre/donations cost code to cover the legal fees of registering the Llangollen Recreation Ground with the Land Registry for Wales.
