- c. CCDF State Plan Amendment outlines a plan to use data to guide program evaluation to ensure continuous improvement in child care settings.

- a. CCDF State Plan Amendment outlines a plan to improve the supply and quality of child care services through recruitment and support efforts.
- b. CCDF State Plan Amendment outlines a plan to provide grants to child care providers to assist with operating costs.
