# Sentencing to Service (STS)

## Roles/Responsibilities

- ▶ Agency/Department/Organization
  - Provides a sentencing alternative for courts
- ▶ Role
  - Supervise non-violent offenders to work on community improvement projects
- ▶ Relationship to Criminal Justice System
  - Judges sentence offenders to STS as an alternative to jail or fines
  - In combination with jail time or as probation sanction
