# **Report Outs:**

- 1. TeamCFA Report and Update: Jason Cole praised the recent TeamCFA Board Governance Training session which was held at VERITAS on February 6<sup>th</sup>. This training session was well attended by members of the VERITAS board as well as a few other TeamCFA schools. The group was reminded about the TeamCFA national conference to be held in Nashville, TN June 22-26. All board members are encouraged to attend. The TeamCFA Board Dinner will be held March 11<sup>th</sup> at the Renaissance Southpark in Charlotte. Members are encouraged to attend.
- 2. Monthly Head of School Report: Katy Ridnouer provided the monthly school update as follows:
  - i. Net enrollment is at 98
  - ii. Recruitment and marketing efforts continue with Open Houses, meetings with parents/guardians from Bethlehem Center, and advertising in local media (e.g. Charlotte Smarty Pants)
  - iii. January MAP test scores are in and the board discussed general class performance. There was much interest from board members regarding the different scores obtained and what they mean regarding student achievement. Katy Ridnouer informed the board that Kristen Rodriquez (the TeamCFA MAP testing representative) will attend a board meeting in the coming months to provide additional information/training on these scores.
  - iv. Updates on EC services and literacy intervention were shared
  - v. Work samples from each grade were shared with the board members
