5. Marriage Certificate (if applicable, Identity Documents for Co-declarant spouse)
6. Birth Certificate(s) of dependent Child(ren) of the Declarant (if applicable)
7. Medical Insurance Coverage \$100,000 (from Canada) at least 1 Year Per Person
8. Job Letter(s) stating Name, Working Since, Weekly Hours, Rate, Job Title etc.
9. Business Registration **AND** Business Statement from your Accountant, CA / CGA / CPA
10. Notice of Assessment (Personal) / Option C Printout / T-4(s) / T-5(s) / and T-1 etc.

11. Bank Balance Letters for Declarant & Co-declarant from Banks in Canada and Overseas Accounts (if applicable)
12. Recent Pay Stubs / Maternity Benefit Stubs / Bank Statements for Direct Deposits / T-4(s) / T-5(s) / T-1
13. Property Tax Documents / Property Ownership Document(s) for the Declarant / Co-declarant (if applicable)
14. Any Letter received by Declarant (As a Sponsor) from CPC or by the Applicant from CPC or Visa Post Abroad
