3. School Certificate(s) / Degree(s) / Diploma(s) etc. (English/French translation and notarized copies)
4. Driver's License(s), Voter Card(s), Ration Card(s) / Aadhaar Card(s) / National Identity Card(s)
5. Business Registration and Business Statement from your accountant (from CA/CGA is recommended)
6. Job Letter(s) stating name, address, working since, weekly hours, rate per hour, job title etc.
7. Notice of Assessment, T-1 General, and T-4(s) for the required years
8. Notice of Assessment for the Corporation, T-2 for the required years
9. Option C Printout for the required years (Call CRA: 1-800-959-8281 Or Online Account)
10. Pay stubs for the required period and year to date
11. Proof of "Other Income" (if applicable)
12. Telephone bills from the appellant and the applicant
13. Letter(s) and Greeting card(s) exchanged between the appellant & the applicant
14. Gift Receipt(s) exchanged between Parents/Grandparents and Child(ren)
15. Photographs of the appellant and the applicant at home or public places/functions
16. Airline ticket(s) and boarding pass(es) if the appellant or applicant paid any visit(s)
17. Proof of Financial Support exchanged between the appellant and the applicant
18. Overseas Joint Bank Account(s) for the appellant and the applicant if applicable
19. Life Insurance Beneficiary Document(s) from the appellant or the applicant
20. Name Change Document(s) for the appellant/Co-signer/ Applicant/ Dependent(s)
