On January 2, 2019, we moved into the previous home of the North Texas Food Bank (NTFB). We are grateful and honored that NTFB entrusted us with this magnificent 72K Sq. Ft. distribution facility in the southern sector of Dallas County. We opened a large, well-equipped client-choice food pantry; the first of its kind in this area. Without advertising, residents quickly found it. Lines for the pantry formed and lengthened daily outside our front doors; the unmet was being fulfilled. Crossroads pantry distributed 920, 905 pounds of food in 2019. On average, the retail value of each pound is \$2.00. Therefore, that same quantity of groceries would have cost our clients \$1,841,810 at the store-money that could have been used for other necessary household expenses. Providing substantial amounts of nutritious food for each household member has been our priority for many years. In 2005, Crossroads developed an algorithm which calculates the approximate amount of groceries needed to prepare 21 balanced meals for each family member according to each person's age, gender and activity level, as recommended by the Dietary Guidelines for Americans. According to Feeding America, the nation's largest domestic hunger-relief organization, this approach was unique. In 2009, to learn more effective ways to alleviate food-insecurity and promote health and well-being, Crossroads began collecting

From our new home, we are poised to increase access to nutritious food beyond the southern sector of Dallas county to include Ellis and Navarro counties. We do this through our distribution network, which in 2019 included 42 NTFB Partner Agencies and 56 active Community Distribution Partners (CDPs). CDPs are churches, community centers, Dallas Housing Authority multi-family housing units, non-profits, etc. that want to regularly feed people in their neighborhoods but do not want to become full-fledged NTFB agencies. They enroll as many as 1,000 individuals to as few as 20 who come at their scheduled time each month. The CDP picks up food in bulk from Crossroads and distributes it the same day-efficient, effective and people get food in their neighborhood. Note: the number of CDPs and Agencies fluctuates from month to month and grows over time. In our first year of operation in this new facility, thanks to our CDPs, Agencies and the NTFB, we distributed 5.5 million pounds-enough groceries for 32,773 people (12,622 of whom are children) to prepare approximately 4.5 million wholesome meals and save our low-income neighbors about \$11,000,000 at the store. In Q4 2019, Crossroads was awarded a large national research grant-The BUILD Health Challenge. As the lead on this grant, Crossroads is partnering with Parkland Health & Hospital System, Dallas County Health and Human

Operating in such a large facility required additional staff and the creation of more extensive, rigorous standard operating procedures and oversight protocols. Maintaining a sanitary and safe work environment is paramount, especially now that we are using rider-jacks and forklifts and handling much more food. We exceeded passing marks for all audits and inspections in 2019. Fortunately, it will be many years before we outgrow this 72K Sq. Ft. facility. Because of the ample amount of room at our location, Crossroads now hosts the Kroger Reclamation Program. On average each week, we receive 24 pallets of various and sundry products from 114 Kroger grocery stores. Roughly, three pallets of product go in the trash, one goes back to the respective manufacturer, and the remaining 20 pallets consists of perfectly good items that Kroger wants our low-income neighbors to utilize. Sorting the myriad of product is an important and fun activity for large volunteer groups. In 2019, the Kroger Reclamation Program yielded 466,000 pounds of donated product which benefits tens of 1,000s of our low-income neighbors.

Form 990, Part III, Line 2 - With the 2018 relocation of Crossroads Community Services from the downtown Dallas location to the southern sector of Dallas, two new programs were added to support expanded services. Partner Relations is a food distribution network in which food is distributed to external organizations. The newly created Hub is a warehouse operation that supports the distribution of food via our pantry and food distribution network.

Form 990, Part III, Line 3 - With the 2018 relocation of Crossroads Community Services from the downtown Dallas location to the southern sector of Dallas and the related expansion of services, the Clothing Distribution Program was retired in order to focus on the increased distribution of food.

Form 990, Part VI, Section A, Line 4 - The Bylaws of the organization were amended as follows: 1) The organization no longer maintains a formal organizational relationship with First United Methodist Church of Dallas ("FUMC"), and the Purpose of the organization was re-stated to eliminate reference to the "urban outreach ministry of First United Methodist Church" as a stated purpose of the organization; 2) the requirement that 1/3 of the Directors of the organization be members of FUMC was eliminated; 3) the Board is explicitly required to hold a minimum of four Board meetings per year; 4) the requirement of an Annual Audit was formally added, consistent with actual organizational policy; 5) Bylaws' policy regarding Indemnification of officers, directors, employees, and agents was restated to ensure clarity; 6) the Organization was granted the power to purchase and maintain Directors' and Officers' liability insurance; and 7) Amendments to the Bylaws will require a 2/3 majority vote of the Directors of the organization.

and preserving historical and geospatial client data; it includes income, demographic, depression and anxiety markers, levels of food-insecurity, general health indicators, social connectivity, etc. In 2011, we were fortunate to establish formal relationships with research partners at UT Southwestern Medical Center and UT Dallas, called CARE (Community Assistance Research); which now includes University of Dallas. Thanks to funding from the W. W. Caruth, Jr. Fund at Communities Foundation of Texas, in conjunction with CARE Crossroads launched a randomized controlled trial of a behavioral-economics informed intervention to improve the scarcity context of budgeting decisions made by low-income households-SNAP-AC Project. Our hypothesis, based on preliminary data, is that by better coordinating use of SNAP and food pantry assistance, households can have more consistent food consumption throughout the month, leading to a higher level of food security and better health outcomes. We invited the North Texas Food Bank and Sharing Life to join us in this important work.
