### WEEKLY HIGHLIGHT

Constance McHugh, the Cedarburg [Wisconsin] clerk, said she and local voters were happy with rules requiring IDs from voters and allowing local officials to open only one office for early in person voting in each municipality. "There have mostly been positive comments that (voters) are glad or relieved that we are finally accepting photo ID," she told the court. Suburban clerks testify in favor of voter ID

City clerks testified in support of Wisconsin's voter ID law and other electionrelated laws in federal court on Tuesday.

Taking the stand for the state's defense in an ongoing federal trial on state election laws, city clerks Constance McHugh, of Cedarburg, and Susan Westerbeke, of Port Washington, said changes including a limit on the number of locations for absentee voting and the elimination of special registration deputies have actually simplified some things for them.

## **NORTH CAROLINA**

All of that leaves elections officials eyeing a potential last-minute scramble if one court or the other changes the rules for the November election through an unexpected ruling. For the time being, backers of the voter ID requirements say data from the March primary is evidence that North Carolina's reasonable impediment safety valve work and most voters are able to comply with voter ID rules.

# **VIRGINIA**

The Democrats behind a lawsuit challenging Virginia's voter ID law will appeal last week's loss in district court to the U.S. Court of Appeals, the lead attorney said Thursday.

The group filed its notice of appeal Wednesday, and will ask for an expedited review by the 4th Circuit Court of Appeals, based in Richmond.

#### MANDATORY VOTER REGISTRATION

### **NATIONAL**

Opponents of automatic voter registration have concerns that the government should not be in the business of telling citizens what to do or that they have to be registered to vote. They may see automatic voter registration as an infringement upon the First Amendment right to free speech.

They question whether Oregon's opt-out form that is sent and received through the mail, in the electronic age, is sufficient to ensure an individual can decline to register. Fraud is also a concern, as some have questioned whether the process can adequately filter out noncitizens who are able to obtain state identification cards legally.

## **CONNECTICUT**

An agreement between Secretary of the State Denise Merrill and Department of Motor Vehicle Commissioner Michael Byzdra to develop an automatic voter registration system is an unnecessary and expensive proposition. That was the message from four Republican lawmakers who held a press conference Wednesday at the Legislative Office Building in Hartford to criticize the decision.

Republicans Critical of Automatic Voter Registration Agreement With DMV

The Republican proposal is an alternative to the costly 'automatic' motor voter registration system proposed by the Secretary of the State. Instead of pursuing the automatic computer system, which failed to garner legislative approval and was initially met with opposition by the DMV due to its cost and customer service challenges, Republicans are proposing the DMV and Secretary of the State work together to enforce the current motor voter registration system with new protocols.

#### **ILLINOIS**

After the Senate easily approved it, the House is poised to take up a proposal in the coming days making the State Board of Elections the clearinghouse for automatically registering voters. By Sept. 1, the board would have to conduct a

voter file update with state agencies' data going back a year. The whole plan would be in place by 2018.

#### **NEW JERSEY**

By a vote of 52-21-1, the full Assembly on Thursday approved legislation (A-1944) sponsored by Assembly Democrats Craig Coughlin, Gary Schaer, Tim Eustace and Joann Downey that would require the New Jersey Motor Vehicle Commission (MVC) to automatically register or update a person's voter registration as part of the process of applying for or renewing a driver's license. ### **NEW YORK**

For example, Gov. Andrew Cuomo recently implemented a system of online voter registration available through the Department of Motor Vehicles. For the first time ever, residents can now use the Internet to register — something that people dwelling in 31 states can do — but only those residents who are existing DMV customers. Owning a car is essential in many Republican-dominated parts of upstate, but not as common in the most liberal pockets of New York City. As a result, Cuomo's fellow Democrats have resisted a plan to create a system of automatic registration through the DMV, as this would seemingly tilt the balance of power in the state's voter rolls away from New York City. ## **OREGON**

However, the turnout rate was lower than in the presidential primary eight years ago and it was unclear what impact the state's new automatic voter registration system had on the election results. Oregon has several hundred thousand more registered voters than eight years ago.
