### **CEIP-MH** Recertification Requirements

### **CEIP-ED** Recertification Requirements

If you are a CEIP-ED, recertification happens through Continuing Education Units (CEUs). For recertification through CEUs, a minimum of 30 hours must be completed in the following way:

- 10 hours of equine-related training (behavior, horsemanship)
- 10 hours of education/coaching-specific continuing education

- 10 hours of attendance at equine interaction conference, workshop, or method training
