## Guest Musician Rules & Application Form

**The City of Fredericksburg's Farmers Market reserves the use of Hurkamp Park on Saturdays and is pleased to offer itinerant musicians the opportunity to perform at the Farmers Market on approved Saturdays.** The Market requires the ability to regulate its designated space to allow the market to run efficiently, but will provide individual musicians the opportunity to exhibit their talents, at no cost to the musician, once an application is submitted and approved.

*Individuals must be from the Fredericksburg/Spotsylvania/Stafford/King George areas.* Guest musician(s) who wish to perform at the Fredericksburg Market shall be limited to no more than 3 hours per day. Instruments shall not be amplified, unless the performer/group is invited and preapproved for a special event in connection with the Market.

Guest musicians are approved or denied at the discretion of the Fredericksburg Farmers Market Manager. Assignments for the day shall be on a first come, first serve basis.
