**\*\*\* Explanation of fees \*\*\***

- (1) Registration Fee includes materials, and must be paid by **ALL** participants.
- (2) Additional cost per person (double occupancy) for those staying on campus (includes all meals except Tuesday night).
- (3) Additional cost per person (private room) for those staying on campus (includes all meals except Tuesday night).
- (4) Additional cost for campsite (for those with trailers/motorhomes) instead of room lodging. Campsite is \$25 per night. (Meals sold separately.)
- (5) Additional fee of \$10 per person, per night, for those staying in trailer/motorhome, including the owner/driver. **\*\*\* Please complete a separate registration form for each additional person, even though he/she may not be attending sessions and/or eating in the cafeteria. \*\*\***
