# Contract Agreement

## A. Before Event

1. W-9 Form (only applies to artist/ performer getting paid)
  1. Artist/performer Agrees to provide Social Security Number (SSN) or Employer Identification Number (EIN), and address prior to Payment on a W-9 form, as required by the Internal Revenue Service.
  
2. Promotional Materials- all promotional materials need to be submitted one week after signing this contract. These materials include headshots and or Artists' / Performer's Biography
  1. Stage Plots – Stage plots need to be submitted one week after signing this contract.

**B. Day of Event**

1. Arrival- All Artist/ Performers should arrive no later than one hour prior to scheduled time of performance.
  1. Tardiness- Artist/performer forfeits any remaining balance shall he/she arrives late. He/she shall adhere to "time of arrival" as indicated on page one of this contract.
  2. Parking- A parking pass will only be provided if specified above. If Concilio does not provide a parking pass the artist/performer will be responsible for paying for their own parking fees unless otherwise agreed upon under contract terms and conditions under travel expenses.
  3. Set up Sound Check Equipment – Unless otherwise agreed by the parties in writing, Artist/Performer shall provide all necessary equipment for the performance at Artist's/ Performers sole expense.

**C. Conduct-Artist(s)** and Artist's/ Performer's employees, agents, servants, representatives shall not be under the influence of any intoxicating beverages, narcotics, or drugs at any time while on Purchaser's property. Any violation of this provision will result in immediate termination of the Contract and this Rider by Purchaser with no liability whatsoever.
