DIRECTIONS:

FROM THE SOUTH:

Take I-43 to exit 152 (Waldo Blvd.) turn East (right) - go 3.5 miles to North 8th Street. Turn North (left) - go 1.2 miles to Albert Drive. Turn East (right) - go 0.7 miles to 40 Albert Drive on the left.

FROM THE WEST:

Take U.S. Hwy. 10 to I-43. Road now becomes Hwy. 310. Continue East 3.5 miles to Hwy. B (3rd round-about). Take first exit (South) - go 2 miles to Albert Drive. Turn East - (left) go 0.7 miles to 40 Albert Drive on the left.

FROM THE NORTH:

Take I-43 to exit 154 East (left) on Hwy. 310. Follow " From the West " directions.

SPECIAL NOTE:

There is a detour on Rapids Road going North from the Holiday Inn. The best alternative route to the agility trial is I-43 North to Exit 152 and follow directions "From The South"
