## The Jayme Closs Abduction, Barron, WI Paradigm Active Shooter, Middleton WI Stratton Way Arson/Homicide, Madison WI

The WAWP welcomes all LE personnel to our annual training conference, featuring recent major Wisconsin case investigations:

**The Jayme Closs Abduction**—Presented by Det. Jeff Nelson, Barron County SO, FBI S/A Jon Hauser, and DCI S/A Joe Welsch. On Oct 15, 2018, Jayme Closs was abducted from her rural Barron home after Jake Patterson forced entry and murdered both her parents. Closs remained captive for 88 days until her escape in January 2019. The investigating Detective and Agents will provide an in-depth case study of this tragic crime, perpetrated by disturbed man with no criminal history. The case received heavy media coverage and brought an entire community together as the search for Jayme extended from weeks to months.

**Paradigm Active Shooter Investigation**— Presented and facilitated by DCI S/A Lou Fernandez and the involved LE personnel. On Sept 19th, 2018, a heavily armed employee of Paradigm (Middleton, WI) entered his workplace began shooting fellow employees. As mayhem ensued, two Middleton officers and two Dane County deputies converged and made entry. The shooter was confronted and lives were saved. S/A Fernandez will provide insight into the incident and the LE personnel who bravely confronted the suspect will provide an inside glimpse into their experience that day—one that anyone with a badge must mindfully prepare for.

**Stratton Way Arson/Homicide**—Presented by ATF Agent Bill Fulton and MFD Investigator Kara Nelson. In September 2017, an entire residential home on Stratton Way in Madison exploded from an apparent gas leak. The resulting investigation took a turn when resident Steven Pirus' wife was located deceased in the basement two days into scene processing. Agent Fulton and Investigator K Nelson will share the details of this fascinating investigation.
