

WARRANTY

Thank you for choosing Innovative Stonecraft stone veneer. Innovative Stonecraft creates only the best product and we take great pride in our product and processes. We guarantee you'll be more than satisfied with your purchase, but, in the unlikely event that a replacement or repair is necessary, Innovative Stonecraft Stone Veneer products are covered under our 50 year limited warranty.

The Innovative Stonecraft Limited Warranty warrants the original owner that the stone veneer product will be free from manufacturing defects for a period of 50 year from the date of original purchase. The Limited warranty extends only to the original purchaser and does not automatically transfer to subsequent owners without a written approval from Innovative Stonecraft.

This Limited Warranty is only applicable if the stone veneer products are installed in compliance with all local, provincial and federal laws as well as building codes. Innovative Stonecraft Inc. assumes no liability in the following events:

- Improper use and application of Innovative Stonecraft veneer products.
- Installation over improperly designed surfaces and use of defected or improper installation materials.
- Product damaged due to accident, neglect or negligence.
- Product damaged from power or chemical wash, varnished, painted over or from airborne contaminants.
- Any damage or injury caused by natural and man-made disasters including but not limited to earthquake, fire, water damage, extreme weather and vandalism.
- Changes in the appearance of veneer products caused by normal weathering or efflorescence. Normal weathering overtime may cause stone surface to fade, accumulate dust, stain or change color.
- Damage resulting from structure or wall

settlement, moisture intrusion or mold.

- Any unforeseen circumstances that are not in control of Innovative Stonecraft Inc.

THIS LIMITED WARRANTY IS THE ONLY WARRANTY MADE BY INNOVATIVE STONECRAFT INC. AND DISCLAIMS ALL AND ANY WARRANTIES, EXPRESS, IMPLIED OR STATUTORY, INCLUDING, WITHOUT LIMITATION, THE WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE TO THE FULLEST EXTENT PERMITTED BY LAW.

This warranty coverage is limited to replacement and repair of stone veneer products only and does not cover labor to remove or install materials. The purchaser shall notify Innovative Stonecraft Inc, in writing, within thirty (30) days of discovering the defect. Innovative Stonecraft is not obliged under this warranty if claim is not notified in writing within thirty days.

The claim should include the proof of the date of purchase, date of installation and detailed pictures of the defects. Innovative Stonecraft will investigate the alleged defect and determine whether it is covered by our limited warranty and be repaired or replaced.

ANY ORAL STATEMENTS BY INNOVATIVE STONECRAFT EMPLOYEES OR DEALERS DO NOT CONSTITUTE WARRANTIES. NO OTHER WARRANTIES ARE GIVEN BEYOND IN THIS WRITING.
