# ALASKA STATE ELKS CAMP RULES

**All persons attending the Alaska State Elks Camp are required to read and adhere to the following rules:**

1. The following are strictly prohibited: profanity in any form, pornography, fighting, possession of weapons or knives of any kind, possession or use of alcohol, tobacco, or drugs.
2. All campers are expected to conduct themselves in a respectful manner that will not disturb other campers or leaders. Noise in the cabin area should be controlled.
3. All persons on the lake must wear camp supplied/approved personal floatation devices.
4. No child is allowed on or in the lake without leader supervision and permission (See Water Safety Program attached).
5. Campers must have counselor or other leader supervision at all times.
6. All fires must be approved by the Camp Directors and must be confined to the pavilion grill or barbecue pit.
7. Cutting of live trees on camp property is prohibited.
8. The picnic area must be cleaned after each use.
9. All cabins must be kept neat and clean. Beds must be made and personal gear stored neatly when not in use.
10. There will be no running or other rough or dangerous play in the shower houses.
11. Bows and arrows will be used only in designated areas with counselor or other adult supervision.
12. Vandalism is not allowed and will not be tolerated anywhere at the camp.
13. No littering: put your garbage in a trash receptacle.
14. **Theft is grounds for immediate expulsion from camp.**
15. The following areas are off limits to campers: caretaker's apartment, storeroom below caretaker's apartment, the shop building, the laundry room, the barn, and the camp office.
16. Participation in activities, including the hike and cabin chores, is mandatory.
17. Electronic devices are not allowed during camp. If cell phones or other electronic devices are brought to camp, they will be held by the Camp Program Director until camper is released for travel home. In the event of an emergency, the camper may be allowed access to their phone.
18. Telephone contact will be made on an "as needed" basis or in case of an emergency. Parents and/or Guardians, please do not plan to have your child check in with you each day!
19. **Above all, HAVE FUN!**

# SPECIAL REMINDER TO PARENTS/GUARDIANS

Phone use will be limited to emergencies only. Cell phones will be retained by the Camp Director upon check in and returned at checkout.

Remember to plan clothing and toiletries carefully and keep in mind that your child will be gone a week with the possibility of various weather conditions. Sturdy shoes are a must and flip flops are encouraged for showering and lake activities. Please use the recommended Supply List as your packing guide as there are no laundry facilities available at the camp.

Campers are welcome to bring spending money to use at the Commissary. Each camper's purchases will be limited to \$2.00 per day and will deposit the money with the Camp Director at check-in for safekeeping.

Each camper needs to bring one white T-shirt for a craft project. It does not have to be new...the perfect chance to cover up those play stains.

Please talk over involvement in this activity carefully with your child. A commitment to attend this camp should be taken seriously. "No Shows" or early departures rob other deserving youth from the opportunity of taking advantage of this wonderful experience.

All campers and their parent(s)/guardian(s) are required to attend a mandatory meeting with their sponsoring Elks Lodge Exalted Ruler or Camp Liaison prior to attending camp. This may be a group or individual meeting at the discretion of your sponsoring Lodge. You will be notified of specifics as we approach the camp dates.
