### **IMPORTANT: THIS IS A LEGAL DOCUMENT**

Please read and understand before signing. If you have any questions please ask us or consult an attorney.

River Run Outfitters LLC would like you to know that a river trip can be dangerous. Unlike a theme park setting, your adventure will take place in a natural environment over which River Run Outfitters LLC has no control. The same elements that contribute to the unique character of river running, such as constantly changing water levels, can cause loss or damage to equipment, personal injury, or in extreme cases, permanent trauma or death. We simply want you to know in advance what to expect, and to be informed of some of the possible risks. We ask that you read this, sign it, and return to our office.

### **ACKNOWLEDGEMENT OF RISK**

As a participant in a river trip, you will be totally and solely responsible for your own movement and safety while on the river. Because your activity takes place in the "great outdoors", you will be solely responsible for your own rescue.

Although accidents are rare, injury may be sustained by (but not limited to) carrying or handling the watercraft, walking or climbing along the riverbank, diving or jumping in to the river, getting into or out of the watercraft, falling out of the watercraft, becoming entangled in or pinned against rocks, branches, logs, down trees, or low water bridges. Of course drowning is always a possibility when around water.

As with any water sport, you may be exposed to periods of sun, wind, rain, lightning, exposure to cold water, insects, animals and plants, all of which may also cause injury, trauma, or death.

### **CONTRACT, WAIVER, RELEASE AND INDEMNIFICATION**

I certify my family, including minor children and myself, are in good physical condition and are fully capable of participating in this river trip. Therefore, I assume all responsibility for myself and my family including my minor children.

I agree to indemnify, and hold harmless River Run Outfitters LLC, their agents, employees, or assigns from all claims, damages, losses, injuries, and expenses arising out of or as a results of participating in any River Run Outfitters LLC activities. I further agree to release, acquit and covenant not to sue River Run Outfitters LLC, their agents, employees, or assigns for any and all actions, causes of actions, claims, damages whether they be in law or equity of whatever kind for, but not limited to, any negligence of River Run Outfitters LLC, myself, my family, my heirs or any minor children in my custody against River Run Outfitters LLC arising out of or as a result of participation in this river trip or any activity offered by River Run Outfitters LLC.

I hereby agree that if River Run Outfitters is obligated to defend, counterclaim or bring any action, lawsuit, litigation or dispute brought against them by myself, my family, my executors, my heirs or assigns or by any minor child that was in my custody at the time of the activity or that they are forced to bring against me, my family, my executors, my heirs or assigns or any minor children that were in my custody, I agree to pay River Run Outfitters LLC's reasonable attorney's fees and costs associated with such defense.

I authorize and release River Run Outfitters LLC the use of my image in any photograph or video recording.

I agree not to take any illegal drugs or excessive alcohol while undertaking any activity with River Run Outfitters LLC.

I agree to return all equipment on time and in the condition in which it was received. I also agree to pay for any equipment which is lost, damaged, or stolen.
