- Senior Veterans, Inc. is a 501 (c) 3 non-profit, EIN #45-4128580. Our Effective Date of Exemption was November 15, 2011. Our IRS Determination Letter may be viewed at [www.seniorvet.org](http://www.seniorvet.org).
- We are **governed** by an elected **Board of Directors**. Section 12 of our Code of Regulations prohibits compensation for our Board members. Our **Code of Regulations, Conflict of Interest Policy and Privacy Policy** are **public documents** and available for viewing on our website.
- **David F. Bolser**, our CEO and Founder, is an **Accredited Claims Agent** with the Department of Veterans Affairs. His accreditation document may be viewed on our "About Us" page.
- Our services are provided **free** of charge. **We serve seniors in all 50 states** and provide them with 24/7 support for the **life** of their claim. We do not receive Federal, State or Local grants or financial assistance of any type. **Our mission continues due to the generosity of our donors as well as merchandise sales.**
- We are **not** Financial Planners, Attorneys or CPA's. We do **not** offer financial, legal or tax advice nor will we refer families to Financial Planners, Attorneys or CPA's. We will **not** act as a placement service for Home Care Agencies, Assisted-Living, Memory-Care or Senior Communities of any type.
- The **Department of Veterans Affairs** are the **sole adjudicators of claims for Pension**. We are **neither** employed by nor do we represent the Department of Veterans Affairs. As required by Federal statutes, we **do** use VA Accredited Claims Agents to assist with the claims process.

- The **claimant** is the one **receiving** the benefit from the VA. The **veteran** is the one whose service records are used to determine eligibility. The veteran and the claimant **can** be the same.
- Over **63%** of those that apply for this benefit are **widows**. Over **90%** are **single**, still **own their home** and live **primarily from Social Security** benefits. Around **85%** of those that apply, **receive care from family members**. Over **60%** of claimants **receive care at home**. The remaining **40%** receive care from **Assisted Living** and **Memory Care Communities** or from private **Home Care Agencies**.
- It takes approximately **57 seconds** for someone to answer the Eligibility Questions from our site and **receive their complete VA Claim Application!**
- Senior Veterans, Inc. helped over **18,000** families in **2013** and over **22,000** families in **2014**. We provide **24/7 assistance** for the **life of the claim**. All services are provided **free** regardless of the complexity of the claim.
- The **U.S. Army** is the **most common branch**, by a 5-1 margin, listed by claimants for Veteran's Pension.
