

**New Student Application fee:** A **non-refundable** \$50 processing fee is due at the time of application.

**Registration Fee:** (for new and returning students) is required when the application is submitted and must be paid in full before registration is complete. It is a **non-refundable** fee unless FMCS chooses not to admit the student. (The fee includes a yearbook per student; annual subscription fee for Renweb app; additional yearbooks can be purchased for \$40.00 each)

**(K-8) A non-refundable** registration fee for each child:

**NEW \*** Continuous Enrollment at FMCS! The obligation to pay tuition to FMCS for each academic year shall become binding on February 5<sup>th</sup> unless FMCS is notified via the opt-out form on or before February 5, 2021.

**Volunteer hours:** Parents are required to volunteer 10 hours per student. If this is not completed by March 31, 2022 your account will be billed \$200.00 per student. (Maximum of twenty hours if you have three or more children)

**Financial Assistance:**

A limited amount of Financial Aid is available based on need and the recommendation from the FACTS Company. Please note timing is very important - refer to Financial Aid packets for information. Financial Aid is available to students in grades K through 8<sup>th</sup> and cannot be used in conjunction with any other discounts.

**K - 8<sup>th</sup> Discounts:** You may apply for **only 1 discount - whichever is the greatest:**

- A \$300 sibling discount is applied (on base tuition) to each successive sibling enrolled at FMCS.
- Discount given on base tuition to children of any full-time pastor. (Contact Mrs. O'Brien)
- A \$300 discount to First Assembly of God tithe paying members
- A 10% discount given to children of FMCS alumni.

*The prepayment discount (see below) cannot be used in combination with any discounts, financial assistance or any scholarships. A family can only use one type of discount. For example, if a person receives a pastor's discount, the multi-child discount would not apply. The only exception is that it is possible to get a pre-payment discount with a multi-child discount.*

**Learning Disabilities Program, K-8<sup>th</sup> Graders** – A program to assist students with mild disabilities who struggle academically within the regular classroom. There are 5 levels of service starting at \$675. See brochure for additional information.

**Payment Terms:** The F.A.C.T.S. tuition management program is set up on ALL monthly accounts. Payments are due on the 5<sup>th</sup> or 20<sup>th</sup> of each month. The annual fee, determined by F.A.C.T.S., is deducted when F.A.C.T.S. receives the agreement. F.A.C.T.S. accepts withdrawals from the following: Credit Cards (Discover, MasterCard or American Express), Debit Cards, Checking Accounts and Savings Accounts. FMCS also accepts Visa, MasterCard and American Express as forms of payment.

**Note:** When insufficient fines occur, a \$50 charge is added each month until the account is in good standing. Payments begin in July depending on your payment plan. All payment plans end in May. Your student(s) will not be allowed to re-register for the next school year unless your school balance is zero. This includes after care, morning care, lunch, all fees, tuition and any other applicable outstanding balances. Tuition payments for students entering FMCS after the school year has begun will be prorated based upon the multiple payment rate unless paid in full at time of entry. Students withdrawn or dismissed from FMCS during a given month will be charged for the full month's tuition. Each account must be kept at a monthly zero balance for a student to attend classes, take exams, and receive his/her quarterly report card or have student records released and transcripts mailed. Upon withdrawal or dismissal all records will be held until the account is paid in full. Lost or damaged book charges will be added to the account.

**Other Enrollment Fees:**

**Middle School iPad Technology Fee:** A \$300 fee due before August 3, 2021

**Late Payment Fee:** A \$25.00 late charge will be added on any account that is more than 15 days in arrears.

**Return Check Fee:** A \$25.00 charge will be assessed for each returned check.

**Withdrawal Fee:** A \$500.00 fee will be charged per student being withdrawn or dismissed May 1 - July 3, 2021 and \$750 if you withdraw after July 3, 2021. In addition to the withdrawal fee any balance remaining on additional fees (library and lunch charges) will need to be paid at that time.
