Dear Brothers and Sisters.

As some of you may know, Don Brandel Plumbing bought C&R Plumbing about a year ago and since have been picking up quite a bit of work. Muir-Chase Plumbing, Murray , Pan-Pacific, and Zeen have also been picking up quite a bit of a backlog of projects as well.

Requirements for Class Reimbursement

We are now able to offer reimbursement for classes taken after January 1, 2013 to all UA journeymen and apprentices who are members in good standing of a local that is part of District Council 16. This program is a result of our placing a nickel an hour in the certification fund two years when we made the changes in our contract.

Reimbursement is solely for training taken outside the apprenticeship training curriculum. All classes must be taken at an A&J Training Center. Forms for reimbursement will be distributed in class or may also be obtained online at www.ajtraining.org.

Reimbursements will be distributed on a quarterly basis, January 1st, April 1st, July 1st, and October 1st. Members must submit the reimbursement request


form to the A&J office. Any forms received after the close of business and ten (10) days prior to the disbursement date will be carried over to the next quarter. There is a maximum of \$550.00 reimbursement per calendar year for each member.

LA City employees under MOU 2 & MOU 13: The City has been somewhat quiet. They have released a RFP for an operator of the Convention Center. We still oppose this but it seems to be moving forward. The Zoo is currently off the table. They are also in the market for new medical providers as a RFP was just released for medical insurance providers. Measure "A" is on the ballot, if it fails, plan to see the CAO come after us again.

Dear Brothers & Sisters,

I would like to thank all of the Brothers and Sisters for their support in my newly elected position as Business Agent for Local 78. I will be overseeing the County, Studios, Race Track and LACCD. I look forward to working for you.

As far as work goes, there are several new projects in the beginning stages of construction including the 8th and Hope project, LA Live Marriot and Kaiser Harbor City to name a few. Last month I attended a ground breaking ceremony for the Wetherly project which is an all-union 12 story luxury condominium. I have also attended several pre-job meetings for projects that should be starting this summer.

There is a \$2 billion mixed use redevelopment project for the Wyvernwood Apartment complex in Boyle Heights. The Los Angeles/Orange County Building Trades have signed an all-union Project Labor Agreement, which will create more than 10,000 construction jobs. I don't have a start date yet, but I will keep you posted.

February 12, 2013 the Lynwood School District unanimously approved a Project Labor Agreement with the Los Angeles/Orange County Building Trades for work to be completed under a \$93 million Bond. With a 30% local hire requirement, this will help the members of Local 78 get back to work.

As for the County, we have started the pre-negotiation process for MOU 411 & 412. I have received some feedback from you, and I have gone over it with the Building Trades and other Trades. We expect to present our proposal to the County sometime in April. I will keep you updated as things progress.
