**A MOTION TO CONFIRM AND ADOPT DRAFT #5, ALTERNATE #1, DATED JUNE 16, 2016 AS THE CURRENT, BUT NOT THE FINAL, DRAFT OF SAID ORDINANCE TO AMEND CHAPTER 4 OF THE CITY CODE BY ADDING NEW SECTIONS 4-85 THROUGH 4-90, DEFINING EVENT FACILITIES AND SETTING FORTH THE REGULATIONS PERTAINING TO THE SAME. THE INTENT OF THIS VOTE TO CONFIRM DRAFT #5 IS TO PRODUCE A DOCUMENT TO DISSEMINATE TO THE VIRGINIA BEACH CIVIC LEAGUES THROUGH THE VIRGINIA BEACH COUNCIL OF CIVIC ORGANIZATION FOR THE PURPOSE OF SOLICITING COMMENTS AND STIMULATING DISCUSSION RELATIVE TO THE REGULATIONS AND THE PERMITTING PROCESS CONTAINED IN DRAFT #5. DRAFT #5 WILL, ADDITIONALLY, BE DISTRIBUTED TO THE BAYFRONT ADVISORY COMMISSION, THE HOTEL / MOTEL ASSOCIATION AND OTHER STAKEHOLDERS OF INTEREST. FOLLOWING CONFIRMATION BY A SUPER MAJORITY OF NOT LESS THAN 75% OF THE COMMISSIONERS ATTENDING AND VOTING, DRAFT #5 WILL BE USED AS THE STARTING POINT FOR PRESENTATION AND INFORMATION GATHERING AT NOT LESS THAN FIVE PUBLIC FORUMS HELD IN LOCATIONS IN THE CITY OF VIRGINIA BEACH WITH PROPER INFORMATION AND ACCEPTABLE INFORMATION CHANNELS USED FOR ANNOUNCEMENTS MADE TO THE GENERAL PUBLIC.**
