JUNE 19, 2020  
VILLAGE ELECTION

- February 19, 2020 - last day for Village Clerk to publish notice designating office of offices to be filled and the term or terms thereof  
*(Election Law § 15-104(3)(a) – at least 4 months prior to election)*
- February 19, 2020 - First Day Village Clerk may accept absentee ballot applications  
*(Election Law § 15-120(4) – not earlier than 4 months prior to election)*
- April 3, 2020 - First Day that individuals may sign independent nominating petitions  
*(Election Law § 15-108(9) – not earlier than 6 weeks before the last day to file independent nominating petition)*
- April 20, 2020 - Last day for the Board of Trustees to adopt a resolution stating the polling place and the hours the polls will be open§  
*(Election Law § 15-104(3) – a least 60 days prior to election)*
- May 8, 2020 - First Day to file and independent nominating petition  
*(Election Law § 15-108(8)(a) – not earlier than 42 days prior to election)*
- May 10, 2020 - Last day for the Board to appoint the election inspectors  
*(Election Law § 15-116(1) – At least 40 days before the election)*
- May 15, 2020 - Last day to file an Independent Nominating petitions  
*(Election Law § 15-108(8) (a) – not later than 35 days prior to election)*
- May 18, 2020 - Last day to file written objections to Independent Nominating Petitions  
*(Election Law § 15-108(10) – not later than 1 day after the last day to file the petition). Since this day falls on a Sunday it will be accepted on the next business day which is Monday*
- May 18, 2020 - Filing of First Statement of Campaign Receipts  
*(Rules of the State Board of Election §§ 6200.1 & 6200.2 – must be 32 days before the election)*
- May 20, 2020 - Last day to file written specifications of objection to Independent Nominating Petitions  
*(Election Law § 15-108(10) – within 2 days after the filing of the written objection)*

- May 18, 2020 - Last day to file certificate of acceptance or declination of Independent Nominating Petitions  
(*Election Law § 15-108(8)(b) – not later than 3 days after the last day to file petition*)
- May 21, 2020 - Last day to file a certificate to fill vacancy caused by declination of Independent Nominating Petitions  
(*Election Law § 15-108(8)(c) – not later than 3 days after the last day to file a certificate of declination*)
- June 8, 2020 - Last day to file second statement of campaign receipts  
(*Rules of the State Board of Election §§ 6200.1 & 6200.2 – must be 11 days before the election*)
- June 9, 2020 - Last day individuals may register with the County Board of Elections  
(*Election Law § 15-118(2) – at least 10 days before the election*)
- June 10, 2020 - Last day for Village Clerk to publish notice stating polling place, hours during which the polls are open, names and addresses of candidates, offices and term nominated for and abstract of any propositions  
(*Election Law § 15-104(3)(c) and (4) – at least 10 days before the election*)
- June 12, 2020 - Last Day for the Board of Elections to provide a list of registered voters to the Village Clerk  
(*Election Law § 5-612(1) – at least 7 days prior to the election*)
- June 12, 2020 - Last day for Village Clerk to receive applications for absentee ballots to be mailed  
(*Election Law §15-120(4) – at least 7 days prior to the election*)
- June 12, 2020 - Last day for Village Clerk to mail absentee ballots  
(*Election Law §15-120(5) – at least 6 days prior to the election*) as 6 days would be a Saturday, this date is for the Friday before
- June 17, 2019 - Sample ballots must be made available for public inspection no later than this day (*Election Law §7-128(1) – Not later than 5 days prior to the election*)- as 5 days would be a Sunday, this date is for the Friday before
- June 18, 2020 - Last day for Village Clerk to receive personal applications for an absentee ballot from applicant or applicant's agent. Upon receipt of application, clerk must deliver absentee ballot to applicant or agent  
(*Election Law §15-120(5) – no later than 1 day prior to the election*)
- June 19, 2020 - Village Election Day
- June 19, 2020 - Last day for Village Clerk to accept absentee ballot

- June 19, 2020 - Village Clerk delivers absentee ballots to board of inspectors  
*(Election Law §15-120(7) – no later than 1 day prior to the election)*
- June 20, 2020 - Inspectors must file a certificate of canvass of voters to Village Clerk  
*(Election Law §15-126(1) – before 9:00 am of the day following the election)*
- June 21, 2020 - Last day for Village Clerk, upon his or her own volition or upon the written request of any candidate, cause a recanvass of the vote cast  
*(Election Law §15-126(3) – not later than 2 days after the date of the election)*
- June 22, 2020 - Deadline which Village Clerk must notify the county board of elections of the request for recanvass  
*(Election Law §15-126(3) – within 1 day after receiving the written request)*
- June 22, 2020 - Last day for Village Clerk to notify successful candidates that they have been elected and must take an oath of office within 30 days after they take office  
*(Election Law §15-128 – within 3 days after the election)*
- July 16, 2020 - Third Filing of Campaign Receipts  
*(Rules of the State Board of Election §§ 6200.1 & 6200.2 – must be 27 days after the election)*
