Open from 7:30 am to 12:30 pm, the Bazaar will feature Christmas items – home-made arts & crafts, decorative items and gifts. Prospective vendors are asked to provide a detailed description and photos (if available) of their items.

Along with Christmas items, there will be food & beverage and commercial booths for sponsors.

Vendors will need to bring all their own set up – canopy, tables, chairs, decorations. Rentals will be available, if needed. Limited electricity is available, but must be pre-arranged with event staff.

This event is being marketed as a community and family event – not exclusively for runners. It is a fun community celebration where people can get into the spirit of Christmas with carolers, family fun and shopping! And it’s also the largest pet adoption event of the season in the East valley. We hope you can join us!

**Fees:** The fee for Commercial Vendors (Non-Sampling) is \$295 for a 10 x 10
