### 2019 Regular Rates

**Mini Camp:** \$1,400.00 plus \$84.00 State Sales Tax = **\$1,484.00**

**One Term:** \$4,000.00 plus \$240.00 State Sales Tax = **\$4,240.00**

**Full Term:** \$7,000.00 plus \$420.00 State Sales Tax = **\$7,420.00**

**LIT Program:** \$7,000.00 plus \$420.00 State Sales Tax = **\$7,420.00**

### 2019 Early Bird Rates (rates expire midnight December 1, 2018)

**Mini Camp:** \$1,200.00 plus \$72.00 State Sales Tax = **\$1,272.00**

**One Term:** \$3,600.00 plus \$216.00 State Sales Tax = **\$3,816.00**

**Full Term:** \$6,000.00 plus \$360.00 State Sales Tax = **\$6,360.00**

**LIT Program:** \$6,000.00 plus \$360.00 State Sales Tax = **\$6,360.00**

*\*State Consumers' Sales Tax of 6% has been added to each fee under West Virginia State Law.*

*\*Tuition fee is designed to cover all expenses at camp except medication and other incidentals. The store account money is not included in the camp fee.*

### DISCOUNTS

1. Additional siblings attending camp will receive a \$200.00 discount.
2. Families who pay in full prior to December 1<sup>st</sup> will receive 5% off tuition. ***Please contact the office to have this discount applied to your account.***

### PAYMENT POLICY

1. All registrations must be accompanied by a \$500 deposit *per child, per term*.
2. Registration and payment are completed online through our website, www.campalleghany.com. Click on "Register for Camp" in the Parents section and follow the prompts.
3. We accept Visa, MasterCard, Discover and e-check.
4. You may log in to your online account and make payments as often as you wish, in any amount, up to April 1, 2019.
5. Any remaining balance will be charged to your account on April 1; you will receive notification a week prior to charging your account.
6. **A 3% service charge will be applied to all unpaid balances after April 1, 2019.**

### REFUND POLICY

1. Withdrawal prior to February 1, 2019: all payments **less a \$100.00 administrative fee** will be refunded.
2. Withdrawal after February 1, 2019, *for reasons other than medical*: the full \$500.00 deposit will be kept.
3. Withdrawal after April 1, 2019, *for reasons other than medical*: the full tuition will be charged.
4. If one sibling withdraws, any payments made toward that camper may be applied to a sibling less the \$100 administrative fee prior to February 1 or less the \$500 deposit prior to April 1.
5. If a full term camper withdraws from one term, the \$100 administrative fee is charged for that term prior to February 1, the deposit is kept prior to April 1, and after April 1 the full amount is kept.
6. If a full term camper withdraws from both terms, the \$100 administrative fee is charged for **both** terms, resulting in a \$200 fee prior to February 1, or \$500 deposit for both terms, resulting in a \$1000 fee prior to April 1.
