2016 MEMORANDUM OF UNDERSTANDING BETWEEN

MORRIS-SUSSEX-WARREN WORKFORCE DEVELOPMENT BOARD

AND ONE-STOP PARTNERS

I. Purpose

The *Infrastructure Funding Agreement* (IFA), also known as Resource Sharing Agreement (RSA), serves as documentation of the modification of the local funding mechanism for the One-Stop Career Centers as determined by the partners of the Morris/Sussex/Warren Workforce Development Board (WDB) in the approved 2016 *Memorandum of Understanding Between Morris-Sussex-Warren Workforce Development Board and One-Stop System Partners*.

The WDB, authorized by the WIOA 2014 legislation, is the administrative agent for the Workforce Innovation and Opportunity Act (WIOA) IFA requirement. This Agreement is between the WDB which includes Employment and Training Services (ETS), and the New Jersey Department of Labor and Workforce Development (LWD) which includes the divisions of Employment Services (ES), Vocational Rehabilitation Services (DVRS), Senior Community Service Employment (SCSEP), Trade Adjustment Assistance (TAA), Jobs for Veterans State Grants (JVSG), WorkFirst (TANF, GA, SNAP), and State Unemployment Compensation (SUC). All parties in this Agreement have been empowered under their respective legislative directives to provide services to customers under WIOA. The partners have program staff members physically present at the One-Stop Career Centers. Although Adult Education and Family Literacy (Title II) and Carl D. Perkins and Technical Education Act partners do not have staff members physically located at the One-Stop Career Centers, on-site staff are appropriately trained to provide information to customers about the programs, services, and activities available through all partner programs.

II. Objective

The objective of this interagency Agreement is to provide a coordinated system of workforce services agreed upon by LWD and WDB as the partners located at the One-

Stop Career Centers (American Job Centers). WIOA and WorkFirst related costs, invoices and payments require approval by the WDB. LWD and the New Jersey Department of Treasury Office is responsible for all fiscal activities of local divisions.

III. Cost Determinations

Customers are in contact with several workforce programs, access multiple services and therefore receive multiple benefits from one or more of the partners. The building lease is the shared cost for carrying out the mutual interests of the MOU partners. Each partner agency is responsible for their ancillary expenses including equipment and technology.

Cost objectives and space distribution, based on square footage, are reviewed biannually and revised yearly by the WDB in collaboration with LWD.

A. Building Costs

LWD has an established facilities cost sharing arrangement with its divisions, in compliance with Subpart E, Federal Cost Principles of the Uniform Guidance at 2CRF part 200. The divisions share the cost of the lease including utilities and maintenance at a cost per square foot assigned.
