BY SIGNING BELOW, APPLICATIONS ACKNOWLEDGE THAT THEY HAVE READ AND AGREE TO THESE TERMS AND CONDITIONS:

The undersigned application hereby requests permission for the Memorialization work as described in this agreement and authorizes the monument company to perform such work at the lot described in this application. The applicant acknowledges that all work and activities conducted within the Cemetery including, without limitations, all memorialization work, are subject to the Rules and Regulations of Lower Brandywine Cemetery, as published and revised from time to time by Lower Brandywine Cemetery, and which are incorporated herein by reference. Terms used in this application and not otherwise defined shall have the meanings ascribed to them in the Rules and Regulations.

If granted, approval of this Application will apply to the precise details and information presented in and with this application. If upon inspection by the Cemetery Manager of the memorial or memorialization work the Cemetery Manager determines that the work is not in strict compliance with the information provided in this application, or does not comply with the rules and regulations, the applicant will correct the memorialization work or remove the monument.

The undersigned Applicant agrees that, should the Monument or other Memorial become unsightly, dilapidated or dangerous to visitors, the Cemetery shall have the right to correct or repair the defective condition or remove the Monument or other Memorial from the Cemetery, at the expense of the Applicant.

IT IS UNDERSTOOD THAT ALL MEMORIAL WORK IS SUBJECT TO ALL THE RULES OF THE CEMETERY IN ANY WAY AFFECTING MONUMENTS, MARKERS, HEADSTONES OR ANY OTHER STRUCTURES OR MEMORIALS, THEIR MANUFACTURE, LOCATION, CARE, INSTALLATION, REMOVAL OR IN ANY OTHER REGARD, SUBJECT TO ALL OTHER RULES AND REGULATIONS OF THE CEMETERY NOW IN FORCE OR HEREAFTER ADOPTED.

The undersigned, who represents that he, she, or they, is or are the sole and exclusive owner or owners of the right of burial in the grave or lot described above hereby authorizes and requests the Superintendent of Lower Brandywine Cemetery to permit the installation of the memorial as described on the reverse side of this application, and the construction of a foundation, and does hereby agree to all the terms, conditions and other provisions as set forth on both sides of this application.

MONUMENT DEALER AGREEMENT

- I certify that I have been authorized by the person making this application, to prepare a memorial for the above-described location and that the reverse side of this agreement contains the specifications and detailed sketch of this memorial.
- I hereby agree to abide by the rules and regulations of this Cemetery now in force or hereafter adopted, and further agree that, if in the opinion of the Cemetery Authorities should the completed memorial not comply with said rules and regulations, if will, at the request of the Cemetery Authorities, be removed by me within three days of such request, without cost to the Cemetery of the Purchaser.
- The undersigned further agrees to hold the Cemetery free from any liability whatsoever for damage to the memorial that may result from the installation of said memorial, before, during or after the setting of said memorial.
- I hereby agree to pay for any damage to lots, graves, walks, trees, shrubs, memorials, etc. during the transportation and setting of this memorial.
- I hereby agree to indemnify, defend and save harmless the Cemetery upon, or from, any and all claims, demands or alleged causes of action arising by reason of the erection of said memorial.
- No memorial, once installed, may be removed from the Cemetery without written permission of the Cemetery Authorities.
- Acceptance of this permit by the Cemetery and the payment for foundation charges or other payments do not constitute complete approval of this application.

SPECIFICATIONS FOR CEMETERY MONUMENTS AND MARKERS

GENERAL REQUIREMENTS FOR MONUMENTS

All Monuments and Memorialization Work shall comply in all respects with the document published by Lower Brandywine Cemetery Titled "Rules and Regulations of Lower Brandywine Cemetery" as the same may be revised and amended from time to time.

GENERAL SPECIFICATIONS

- Manufacturer's logos, guild seals, and other product labeling from any source shall not be visible on the Monument. Any such logo or seal shall be placed on the underside of the Die or Base of the Monument.
- Monuments shall consist entirely of granite, and shall be free from all flaws and defects and manufactured with high quality workmanship.
- The Base and Die shall be the same grade of granite color.

UPRIGHT MONUMENTS ON LOTS 3 GRAVES WIDE AND LARGER

Bases:

- Maximum base 78" long x 16" wide x 10" high

Die

- Maximum die size is 60" wide x 10" thick. Maximum height above ground is 42".

UPRIGHT MONUMENTS ON LOTS 2 GRAVES WIDE

Bases:

- Maximum base 60" long x 14" wide x 8" high

Die

- Maximum die size is 46" wide x 8" thick. Maximum height above ground is 36".

UPRIGHT MONUMENTS ON SINGLE GRAVE LOTS

- Upright Monuments are not permitted on single Grave Lots. Flat Markers on a single adult Grave Lot shall be twenty-four (24) inches wide and twelve (12) inches in height. Request for larger flat markers must be issued in writing.

FLAT MARKERS

- Flat Markers on Cremation Graves shall be standard twenty-four (24) inches wide and twelve (12) inches in height. No larger markers are permitted.
- Flat Markers on Infant Graves shall be eighteen (18) inches in length and nine (9) inches in width.
