READ CAREFULLY - WAIVER AND RELEASE OF LIABILITY

In consideration of Paumanok Tours, Strong Pointe Productions, and the Three Village Historical Society furnishing services and/or equipment to enable me to participate in certain activities, I acknowledge and agree as follows:

I fully understand and acknowledge that:

- (a) Outdoor recreational activities have inherent risks and dangers, and such exist in my use of Paumanok Tours' kayaking equipment and my participation in the activities of Paumanok Tours, Strong Pointe Productions, and the Three Village Historical Society.
- (b) My participation in such activities and/or use of such equipment may result in, but is not limited to, bodily injury, disease, strains, fractures, partial and/or total paralysis, eye injury, blindness, cuts and bruises to the skin, heat stroke, heart attack, death or other ailments that could cause serious disability.
- (c) These risks and dangers may be caused by the negligence of the owners, employees, officers or agents of Paumanok Tours, Strong Pointe Productions, and the Three Village Historical Society, the negligence of the participants, the negligence of others, accidents, breaches of contract, animals, the forces of nature or other causes.
- (d) These risks and dangers may arise from foreseeable or unforeseeable causes including, but not limited to, guide decision making, including that a guide may misjudge terrain, weather, trail or river route location, and water level, risks of falling out of or drowning while in a raft, canoe, or kayak and such other risks, hazards and dangers that are integral to recreational activities and/or use of equipment.
- (e) By my participating in these activities and/or use of equipment I hereby assume **ALL** risks and dangers and all responsibility for **ANY** losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers, employees of Paumanok Tours, Strong Pointe Productions, or the Three Village Historical Society.
- (f) I hereby assume all risk and responsibility of and for any and all damage, loss of theft of the rental boats and/or equipment, or any portions thereof, including but not limited to vandalism or theft, and shall pay the lessor (Paumanok Tours) the full cost of repair or replacement.
- (g) I understand that any photograph taken of me and/or minor children by agents of Paumanok Tours, Strong Pointe Productions, or the Three Village Historical Society may become their property and I hereby authorize use of such photos for brochures, slideshows and other promotional materials.

I, on behalf of myself, my personal representatives, next of kin and my heirs, hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify Paumanok Tours, Strong Pointe Productions, and the Three Village Historical Society from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of Paumanok Tours' equipment or my participation in any of their activities. I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the owners, agents, officers or employees of Paumanok Tours, Strong Pointe Productions, and the Three Village Historical Society.

I HAVE READ THE ABOVE WAIVER AND RELEASES AND BY SIGNING IT AGREE THAT IT IS MY INTENTION TO EXEMPT AND RELIEVE PAUMANOK TOURS, STRONG POINTE PRODUCTIONS, AND THE THREE VILLAGE HISTORICAL SOCIETY FROM ANY LIABILITY FOR ANY AND ALL PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFULL DEATH CAUSED BY NEGLIGENCE OR ANY OTHER CAUSES
